A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING AND ADOPTING THE "MONROE COUNTY MULTI-JURISDICTIONAL PROGRAM FOR PUBLIC INFORMATION" (PPI) IN FURTHERANCE OF THE CITY'S EFFORTS TO FURTHER REDUCE FLOOD INSURANCE RATES COMMUNITYWIDE VIA THE COMMUNITY RATING SYSTEM (CRS); THANKING VOLUNTEER COMMITTEE MEMBERS REBECCA HORAN WITH ATLANTIC-PACIFIC INSURANCE AND JAY W. HALL WITH BB&T BANK FOR THEIR PARTICIPATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, during 1971, the City of Key West joined the National Flood Insurance Program (NFIP) and adopted the FEMA Flood Insurance Rate Maps; and

WHEREAS, during 2016, Monroe County and the individual jurisdictions within it formed the Monroe County Multi-jurisdictional Program for Public Information Committee, with the City Commission appointing three representative thereto; and

WHEREAS, during 2016, the City of Key West's application to join the NFIP's (National Flood Insurance Program) voluntary Community Rating System (CRS) to provide residents of the City with flood insurance discounts was approved; and

WHEREAS, the City of Key West supports the goals of the CRS Program for Public Information to broaden public understanding of flood hazards, flood mapping, floodplain management, development planning, flood insurance, reducing future flood damage and saving lives; and

WHEREAS, the Monroe County Multi-jurisdictional Program for Public Information identifies important messages and means of communicating flood hazard information to target audiences; and

WHEREAS, upon approval of the Monroe County Multi-jurisdictional Program for Public Information, points earned through the plan's implementation will be used to enhance the municipality's CRS rating to help further reduce the cost of insurance rates for the residents.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Monroe County Multi-jurisdictional Program for Public Information (PPI) is hereby accepted and adopted as part of the City's efforts to further reduce flood insurance rates through participation in the Community Rating System (CRS).

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
