A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), APPROVING ADDITIONAL LIGHTING AND DECORATIONS IN AN AMOUNT NOT TO EXCEED \$5,000.00 FROM BRANDANO DISPLAYS, INC. ACCORDANCE WITH THE CONTRACT AWARDED IN CRA RESOLUTION 18-216 AND EXTENDED IN RESOLUTION 21-120: AUTHORIZING THE CITY MANAGER EXECUTE ANY NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING NECESSARY BUDGET TRANSFER(S); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 18-216, the CRA awarded a three-year contract to Brandano Displays, Inc. in response to RFP 05-18 and extended the contract for two years plus six months in Resolution No. 21-120; and

WHEREAS, at its meeting of September 13, 2023, the Key West Bight Management District Board recommended approval of additions and improvements to the holiday lighting plan, and an additional \$5,000.00 in funding for the 2023-24 holiday season under the contract to Brandano Displays, Inc. through Resolution KWB #23-18; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR

AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That additional displays are hereby authorized in an additional amount not to exceed \$5,000.00 pursuant to terms contained in the CRA contract with Brandano Displays, Inc.

Section 2: That these additional displays are budgeted in account # 405-7504-575-4800, promotional expenses, and any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

<u>Section 4</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
