A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A CHANGE ORDER FROM CHARLEY TOPPINO AND SONS, INC. IN THE AMOUNT OF \$62,817.67 FOR THEFRANCES STREET/JAMES STREET CONNECTIVITY SIDEWALK TASK ORDER; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 22-289, the City Commission awarded ITB #22-010 for Right of Way Improvements Contract, to provide paving services and sidewalk improvements, along City rights-of-way to Charley Toppino & Sons, Inc.; and

WHEREAS, in Resolution No. 23-156, the City Commission approved a Task Order not to exceed \$202,199.61 for Frances Street/James Streets Sidewalk Connectivity project for additional sidewalk and curbing, including furnishing and installation of a Rectangular Rapid Flashing Beacon (RRFB) at the Eaton - Frances Streets intersection; and

WHEREAS, during construction of Frances Street/James Streets Sidewalk Connectivity project, it was determined that additional sidewalk and D and F curbing was needed to

accommodate drainage, traffic calming at Frances Street, and to improve overall pedestrian safety; and

WHEREAS, City staff is presenting the proposed placement of the RRFB at the Eaton and Frances Streets intersection to the City Commission to allow for confirmation prior to proceeding with installation at the crosswalk; and

WHEREAS, City staff recommends approval of a Change Order in the amount of \$62,817.67 to install additional sidewalk and D and F curbing to accommodate drainage, traffic calming at Frances Street, and to improve overall pedestrian safety; and
