**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-771(3)(c) OF THE CODE OF ORDINANCES THE DISPOSAL OF UP TO THREE SURPLUS AND OBSOLETE CITY-OWNED VEHICLES, SET FORTH IN THE ATTACHED "EXHIBIT A - VEHICLE LIST" THROUGH A BULK SALE BID REQUEST PROCESS TO THE HIGHEST BIDDER; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, City staff recommends disposal of surplus and obsolete city-owned vehicles, located at various locations around the City, through a bid request process for bulk sale to the highest bidder; and

WHEREAS, Code of Ordinances Section 2-771.3.(c) provides that disposal of surplus or obsolete personal property with acquisition prices in excess of \$50,000.00 shall be made only after approval by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby authorizes the disposal of up to three (3) decommissioned ambulances originally purchased at the inception of the Key West Fire Department's EMS Division, which have reached the end of their useful life as

Advanced Life Support (ALS) response vehicles, as more particularly described in the attached *Exhibit A - Vehicle List*, pursuant to Section 2-771(3)(c) of the Code of Ordinances, through a bid request process for bulk purchase by the highest bidder(s).

Section 2: That the City Manager, upon advice and consent of the City Attorney, is authorized to execute all necessary documents to advertise and solicit bids and complete the transaction(s).

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
