SECTION 2. That Sloppy Joe's Bar is hereby granted permission for the closure of Greene Street between Duval and Ann Streets on the date and during the hours stated above.

SECTION 3. That pursuant to Section 18-86 of the Key West Code of Ordinances, Sloppy Joe's is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 4. That Sloppy Joe's will adhere to the recycling plan of the City Of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they

will be placed side by side.
