A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RE-SCHEDULING THE REGULAR CITY COMMISSION MEETING OF MARCH 16, 2021 TO A SPECIAL MEETING ON MARCH 31, 2021; RESCHEDULING THE REGULAR CITY COMMISSION MEETING OF APRIL 6, 2021 TO APRIL 13, 2021; RESCHEDULING THE REGULAR CITY COMMISSION MEETING OF JUNE 1, 2021 TO JUNE 2, 2021; STATING THAT ANY MATTERS SCHEDULED OR POSTPONED AT A PRIOR MEETING TO THE MARCH 16 AGENDA SHALL BE PLACED ON THE MARCH 31 SPECIAL AGENDA, ANY MATTERS SCHEDULED OR POSTPONED AT A PRIOR MEETING TO THE APRIL 6 AGENDA SHALL BE PLACED ON THE APRIL 13 AGENDA, AND ANY MATTERS SCHEDULED OR POSTPONED AT A PRIOR MEETING TO THE JUNE 1 AGENDA SHALL BE PLACED ON THE JUNE 2 AGENDA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission finds that it is necessary to adjust the regular meeting schedule to assure public notice is provided, by rescheduling the March 16<sup>th</sup>, 2021 meeting date to a special meeting on March 31<sup>st</sup>; and

WHEREAS, the City Commission finds that it would be beneficial to additionally adjust the regular meeting schedule, and move the April 6<sup>th</sup>, 2021 meeting date to April 13, 2021; and

WHEREAS, the City Commission finds that it would be additionally beneficial to adjust the regular meeting schedule, and move the June 1st meeting date to June 2nd, 2021; and

WHEREAS, any matters scheduled at a prior meeting to the March 16th meeting agenda shall be heard on March 31<sup>st</sup>, any matters scheduled at a prior meeting to the April 6<sup>th</sup> meeting agenda shall be heard on April 13<sup>th</sup> and any matters scheduled at a prior meeting to the June 1<sup>st</sup> meeting agenda shall be heard on June 2<sup>nd</sup>; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission meeting previously scheduled for March 16, 2021, is hereby re-scheduled to a Special Meeting on March 31, 2021.

Section 2: That the City Commission meeting previously scheduled for April 6, 2021, is hereby re-scheduled to April 13, 2021.

Section 3: That the City Commission meeting previously scheduled for June 1, 2021, is hereby re-scheduled to June 2, 2021.

Section 4: Agenda items previously scheduled or postponed for March 16 shall instead be placed instead on the

March 31 City Commission Special Meeting agenda; agenda items previously scheduled of postponed for April 6 shall instead be placed on the April 13 City Commission agenda, and agenda items previously scheduled or postponed for June 1<sup>st</sup> shall instead be placed instead on the June 2<sup>nd</sup> City Commission.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
