On May 31, 2023, at approximately 0149 hours, Ofc. Roman, Sgt. Revoredo, and I, Ofc. Bernatova, responded to 208 Duval Street (Tree Bar), in reference to the female subjects refusing to leave.

BWC activated

Upon arrival, I saw a reporting party - security employee of Ricks Bar and Tree Bar (identified by his Florida driver license as Raymundo Acedera, DOB 03/15/1985), talking to two white females.

Acedera pointed to the females and told me they are causing issues are refusing to leave the establishment. Acedera later told me both females came in highly intoxicated, tried to order pizza at Angelina's Pizza (part of Ricks Bar, next to Tree Bar), but would not offer payment, so were asked to leave the line to allow other customers to order. Females did not leave the line and started insulting the staff. Females were going back and forth to the Tree Bar and touching and flirting with the customers seated there. Acedera asked females to leave multiple times, but they just kept insulting him and would not leave, continuing to disturb other customers.

Acedera told me he wished to have both females removed and trespassed from the establishment.

I turned to the females and asked them to step outside so we can talk.

Both females were laughing and asked me who I am to tell them what to do.

Eventually the females were escorted to the sidewalk by Sgt. Revoredo, Ofc. Roman and I.

Females were later identified as Sabina Kalinina, DOB 07/05/1988, and Vlada Davidova, DOB 04/04/1981.

I attempted to speak to Sabina and Vlada, but they were both too intoxicated to have a conversation.

I asked Sabina and Vlada to identified themselves so I could document the trespass warning.

Sabina and Vlada refused and started walking away.

I told Sabina and Vlada they need to identify themselves before they leave and they both started screaming and flailing their hands in aggressive manner towards me and other Officers.

Both Sabina and Vlada were handcuffed and escorted towards the patrol vehicles.

When Ofc. Roman and I were handcuffing Sabina, she did not follow verbal commands and was pulling away from us the entire time.

Vlada was placed to the back of Ofc. Roman's patrol vehicle, and Sabina to the back of mine.

I went back to Ricks to speak with Acedera to gather more information.

When I returned to the patrol vehicles (parked on Charles Street), I saw Sabina laying on the ground next to my patrol vehicle, and Ofc. Roman and Sgt. Revoredo trying to control her arms and legs by holding her down. Sabina

was screaming and trashing. Ofc. Roman later told me Sabina slipped her handcuffs and they opened the rear door of my patrol vehicle to place her back in handcuffs when she leaped out of the car and started thrashing her whole body around. Ofc. Roman told me Sabina was actively trying to bite her the entire time and squeezed the skin of Ofc. Roman's hand between her fingers causing her pain. Sgt. Revoredo told me Sabina kicked him multiple times in his thighs and groin area and punched him in the face.

I applied hobble device to immobilize Sabina's legs, and we placed her at the back of my patrol vehicle again.

Sabina kept screaming and thrashing at the back of my patrol vehicle. When I went to check on her to make sure she was not further injuring herself, I noticed she had one handcuff slipped off of her left wrist again.

K9 Ofc. Hansell and Ofc. Ham responded to the scene and K9 Ofc. Hansell and I opened the rear door to re-adjust Sabina's handcuffs.

Sabina slipped out of the hobble device and leaped out of the back seat, hitting me in the face with the loose opened attached handcuff, causing a laceration on the left side of my face, between my nose and upper lip, as well as internal laceration on my upper lip.

I stepped away and eventually Officers were able to double handcuff Sabina and apply hobble again and place her at the back of my patrol vehicle, using drive stun taser to gain compliance.

Vlada was arrested by Ofc. Roman for Resisting with violence and Battery on LEO under the same case number.

I transported Sabina to Lower Keys Medical Center for medical clearance, and then to Monroe County Detention Center.

My BWC was activated for every interaction with Sabina. My Axon in-car rear camera was activated the whole time Sabina was at the back of my patrol vehicle.

Based on all the facts and circumstances, I found probable cause Sabina refused to identify herself to law enforcement officers, violating FSS 843.02 Resisting officer without violance.

Based on all the facts and circumstances, I found probable cause Sabina knowingly and willfully resisted Officers by offering violence (swinging towards the Officers, and attempting to kick and bite them), violating FSS 843.01 Resisting officer with violence to his or her person.

Based on all the facts and circumstances, I found probable cause Sabina knowingly committed three counts of battery upon a law enforcement officer by pinching Ofc. Roman, punching and kicking Sgt. Revoredo, and hitting me in the face with the open handcuff, violating FSS 784.07(2)(b).

At the time of our interaction with Sabina and Vlada, Ofc. Roman, Sgt. Revoredo and I were all engaged in the lawful performance of our duties, in full police uniform, with badge clearly displayed.

This case is cleared by arrest.

On May 31, 2023, at approximately 0240 hours, I, Ofc. S. Ham responded to 202 Duval St., to assist with a trespassing.

Upon arrival, both females were detained and inside the back of Ofc. A. Bernatova and Ofc. V. Roman's patrol vehicles. I asked Ofc. Bernatova if she needed any further assistance and she stated they had everything they needed. I was about to leave the area when I heard Ofc. M. Hansell state the female in the backseat of Ofc. Bernatova's vehicle had escaped from her handcuffs. I was advised the female had already been previously combative and I stayed on scene while Ofc. Hansell, Ofc. Bernatova, Ofc. Roman and Sgt. N. Revoredo attempted to reapply the handcuffs.

The backseat door was opened, and the female began to swing her hands at Ofc. Bernatova and Ofc. Hansell. I walked around to the other side of the vehicle to assist with controlling the female. I noticed Ofc. Bernatova was bleeding from her upper lip and an Axon body camera was knocked on the ground. I retrieved the body camera and set it up on the patrol vehicle. I grabbed ahold of the female's right arm as we attempted to control her and readjust the handcuffs. The handcuffs that were applied again were too large for her wrist. I provided a set of smaller handcuffs to be applied. While the female was in a standing position, Ofc. Hansell attempted to apply a hobble to the female's ankles. The female continued to kick both legs and shake the hobble off before being tightened. The female was given multiple commands to stop resisting but she refused to listen.

A drive stun was applied to gain compliance from the combative female. The female complied enough for the hobble to be secured onto her ankles. Ofc. Hansell and I assisted with placing the female back into the backseat of the patrol vehicle.

I spoke with the management at Rick's bar (Raymundo Acedero) and retrieved surveillance footage from the incident. Raymundo stated the camera that captured the majority of the incident was unable to be copied onto a disk or thumb drive. I recorded the incident with my Axon body camera and Axon capture application.

A second camera was located in front of The Red Garter that captured the other female's interaction with Sgt. Revoredo and Ofc. Roman. I retrieved a copy of the incident on a flash drive. I uploaded a copy of the surveillance video to evidence.com and packaged the flash drive as evidence.

I submitted the flash drive to KWPD property and evidence division. My Axon BWC was activated and uploaded. All videos captured by Axon Capture have been uploaded to evidence.com.

On 05-31-2023, I K-9 Ofc. Matthew Hansell of the Key West Police Department, responded to 208 Duval St. after hearing what sounded like a disturbance from officers already on scene at Ricks Bar in reference to a trespass.

Upon arrival, I met with Ofc. Roman, Ofc. Bernatova and Sgt. Revoredo, who had two females detained in police cars for trespassing at Rick's Tree Bar and battery on law enforcement officer.

During this time, I observed one of the females Sabina Kalinina, who was in the back of Ofc. Bernatova's patrol vehicle, slip her hand cuffs off her right arm.

I informed Ofc. Bernatova of what I saw and made my way to the rear passenger door, where Kalinina was detained. I opened the door and grabbed ahold of Kalinina by the right shoulder and arm, while Ofc. Bernatova controlled her left side. Kalinina at this point became enraged and began flailing her body around the rear seat compartment of the vehicle, at one point striking Ofc. Bernatova in the face with the hand cuffs that were still attached to her left arm.

We took Kalinina out of the patrol vehicle and with the assistance of Ofc. Roman and Ofc. Ham held Kalinina up against the side wall of Ricks while attempting to put her back into hand cuffs.

I was able to place two sets of hand cuffs on Kalinina and then attempted several times to re-attach her leg hobble that she had slipped out of on her prior struggle with officers, however Kalinina kept struggling with officers and held her feet in place along with attempting to kick out.

At one point I asked Sgt. Revoredo to taser Kalinina in order to gain some sort of compliance. Sgt. Revoredo provided three dry stuns for compliance, and I was able to get Kalinina hobbled and placed back in Ofc. Bernatova's patrol vehicle.

I followed Ofc. Bernatova to Lower Keys Medical Center for clearance prior to going to the jail. Once at the medical center, Kalinina continued her aggressive behavior and had to be place into a wheelchair in order to get her into the ER for medical clearance. While in the ER Kalinina yelled and screamed to a point she nearly passed out.

Once cleared from the ER I assisted Ofc. Bernatova with taking Kalinina to the Monroe County Jail. Once at the jail I removed the hobble and assisted Kalinina into the intake area where she was processed. I later took Ofc. Bernatova's and Ofc. Roman's Axon cameras to the police station for uploading in order to assist with expediting their reports.

My Axon BWC was on for this event.

On 05/31/23, at approximately 0149 hours, I (Sgt. N. Revoredo) responded as a back up unit to assist Ofc. Bernatova and Ofc. Roman with two trespassers that were refusing to leave the property of 202 Duval Street (Rick's Complex).

Upon arrival, I saw Ofc. Bernatova and several employees trying to convince two females to leave the property. The females ultimately complied with leaving the establishment, but when we attempted to identify the females, to complete paperwork for trespass warnings per management, they did not want to comply and one of the females advised she was not going to provide her identification. Ofc Bernatova attempted to gain compliance several times, but the females refused to identify themselves. One of the females, whom we later identified as Vlada Davidova, tried pushing past Ofc. Bernatova and Ofc. Roman and I were able to take her into custody. While Ofc Roman and I were taking Davidova into custody, she attempted to pull away and tensed up in order to defeat our efforts. After taking Davidova into custody, the other female, whom we later identified as Sabina Kalinina, started tensing up with Ofc Bernatova. Ofc Roman assisted Ofc Bernatova in taking Kalinina into custody, whom also tensed and attempted to pull away from officers. Both females were escorted to the marked patrol vehicles at the corner of Charles and Duval Streets.

At the patrol vehicles, Ofc Bernatova was able to place Kalinina into the rear passenger side. Ofc Roman and I had to remove one of Davidova's handcuff restraints in order to remove her purse and other belongings before placing her into the rear of the vehicle. When we removed the handcuff restraint, Davidova attempted to provide resistance and tried to spin herself around to face us. Ofc Roman and I were able to keep Davidova from doing so and were able to re-engage the handcuff restraint. As Ofc Roman attempted to place Davidova in the rear passenger side of her marked patrol vehicle, Davidova was able to turn her body while in a seated position and forcefully kick Ofc Roman in the chest. As Davidova continued to provide resistance by kicking at Ofc Roman, I had Ofc Roman move out of the way and leaned into Davidova to push her legs against her body to prevent her from further kicking. As I did this, I attempted to place the seatbelt restraint on Davidova, but she started screaming "Fuck You" and moved her head towards me as though she was going to head-butt me or bite at me. I used my left forearm to hold her face and head in a stable position against the rear of the seat and was able to securely fasten the seatbelt restraint.

As Ofc. Bernatova was gathering the information for the manager of the Rick's Complex, Ofc. Roman and I noticed that Kalinina had slipped out of her handcuff restraints. I spoke with Kalinina about what she had done and that we needed to place them back on her. I advised Kalinina that I did not want to punch or kick when we placed the handcuff restraints back on her, but Kalinina tried to prevent me from being able to re-engage the handcuff restraints by punching at me. I pushed her body against the partition to prevent her from striking me further, but Kalinina was able to twist her body and kicked at me, striking me in the groin area. I pulled Kalinina out of the vehicle as she continued to kick at me. As Kalinina went to the ground, I wrapped my legs around hers and knelt down into her hip area to prevent her from flailing her lower body as Ofc. Roman and I attempted to gain control of her hand to re-engage the

handcuff restraints. Ofc. Bernatova arrived to assist and placed a Hobble device on Kalinina's ankle area of both feet. Ofc. Bernatova, Ofc. Roman and I were able to reposition Kalinina and re-engaged the handcuff restraints before placing her back into the rear passenger side of Ofc. Bernatova's patrol vehicle.

Sgt. Malsheimer was notified regarding the use of force.

While waiting for Sgt. Malsheimer to arrive on scene. Kalinina was able to remove her handcuff restraints and the Hobble device. Ofc. Bernatova, Ofc. M. Hansell and Ofc. Roman again attempted to gain compliance by giving commands to Kalinina regarding her movements and needing to re-engage the handcuff restraints. As officers attempted to gain control of Kalinina, she punched at Ofc. Bernatova and struck her in the face with the loose handcuff restraint causing a laceration on the outside and inside of Ofc. Bernatova's upper lip and gum area. Officers were able to get Kalinina against the outside wall of 202 Duval Street in an attempt to restrict her movements and re-engage the handcuff restraints and Hobble device. Officers were able to get the handcuff restraints back on Kalinina, but she started kicking at Ofc. M. Hansell as he tried to reapply the Hobble device. I used my Taser device to deliver three cartridge-on drive stuns in order to gain compliance. After the third delivery of the cartridge-on drive stun, Kalinina complied and officers were able to apply the Hobble device and place her in the rear passenger side of Ofc. Bernatova's marked patrol vehicle.

Both arrestees were banging their heads against the windows and continued to be non-compliant while being transported to Monroe County Detention Center. Additional officers and MCDC detention deputies were required to assist with getting both females into the intake area.

My BWC was activated during this encounter. See original reports and supplementals for additional information.

On May 31, 2023, at approximately 0205 hours, I Officer V. Roman responded to 208 Duval Street, Key West, Florida in reference to two trespassers refusing to leave the Tree Bar and Angelina's Pizzeria.

Upon arrival, I observed two white females later identified as Vlada Davidova (DOB: 04/04/1981, Arrestee) and Sabina Kalinina (DOB: 07/05/1988, Arrestee) who were standing in Angelina's Pizzeria surrounded by Tree Bar security who were requesting they both be trespassed from the property after causing a disturbance.

At this time, Officer A. Bernatova approached the females and requested they exit Angelina's Pizzeria to investigate further.

While attempting to speak to Vlada and Sabina, I requested that Vlada and Sabina provide their identifications. Vlada then attempted to walk away refusing to identify herself. As I grabbed Vlada's right arm as she was trying to walk away, Vlada pulled her arm and body away as she yelled "Don't touch me." I continued to ask Vlada to identify herself as she continued to walk away from me, Officer Bernatova and Sergeant Revoredo.

At this time, I approached Vlada along with Sgt. Revoredo. I attempted to grab Vlada's right arm to detain her as we conducted our investigation. Vlada continuously tensed up and attempted to pull her arms away from me and Sgt. Revoredo.

After securing Vlada in handcuffs, Sgt. Revoredo escorted Vlada to my marked patrol vehicle to allow me to assist Officer Bernatova secure and escort Sabina who was also actively resisting. I assisted Officer Bernatova then escort Sabina towards her marked patrol vehicle.

As I was walking towards our marked patrol vehicles parked along Charles Street, I observed Vlada still actively resisting Sgt. Revoredo as she was secured. I then assisted Sgt. Revoredo with Vlada to gain compliance. Vlada was escorted to the hood of my patrol car where she was unsecured to remove her black purse from her left shoulder. Vlada continued to tense up, attempting to pull her hands and body away from me and Sgt. Revoredo.

After removing the black purse from Vlada, I resecured her in handcuffs and escorted her to the rear passenger side of my patrol vehicle.

As I opened the patrol car door, I instructed Vlada to sit in the back seat. Vlada then threw herself on onto the rear passenger side floorboard. At this time, I grabbed onto Vlada and attempted to assist her onto the rear seat of my patrol car. After assisting Vlada onto the seat, I attempted to secure Vlada with a seatbelt. Vlada then sat back placing her back on the patrol car partition and began kicking with both of her feet towards the outside of my patrol car, striking

me multiple times in the chest and stomach causing my body camera to fall onto the sidewalk.

Sgt. Revoredo approached my vehicle to assist as Vlada continued to resist him, kicking, and attempting to exit out of my patrol vehicle. After several minutes, Sgt. Revoredo was able to properly secure Vlada in a seatbelt.

While searching Vlada's purse incident to arrest Vlada continued to kick back seat and door of my patrol car on and off during my time on scene.

After searching Vlada's purse and placing it in the rear trunk area of my patrol car, I observed Sabina kicking the back door of Officer Bernatova's patrol car. As I approached the rear passenger side of Officer Bernatova's patrol car, me and Sgt. Revoredo observed that Sabina had removed her hand from the handcuffs placed on her prior to being placed inside the vehicle. As Sgt. Revoredo opened the rear passenger door of Officer Bernatova's vehicle to resecure Sabina back into her handcuffs, Sabina began swinging and kicking at Sgt. Revoredo.

I assisted Sgt. Revoredo with Sabina who was actively resisting. Sabina continued to kick at Sgt. Revoredo. While holding onto Sabina's face she attempted to bite me on my hands and arms multiple times. Sabina then began to swing the one handcuff on her left hand towards me and Sgt. Revoredo, causing me to grab onto the unsecured portion of the handcuff before placing it under my left knee to prevent her from causing harm to me and Sgt. Revoredo. Sabina continuously pulled her arms and hands from my control. As I grabbed onto her hands to reposition them, Sabina grabbed onto my fingers pinching them with her finger while in the grip of her hand.

After a hobble was placed on Sabina by Officer Bernatova, I assisted with rolling Sabina onto her stomach to resecure her in handcuffs. Sabina was then placed back into the rear passenger seat of Officer Bernatova's vehicle.

Approximately 5 minutes later, I was alerted by Officer Hansel that Sabina was attempting to remove her hand from the handcuffs again as she was still in the back seat of Officer Bernatova's patrol car. As I observed Sabina from the outside window of the rear passenger side, I noticed she removed her right hand from the handcuffs. I then assisted Officer Hansell and Officer Bernatova who were attempting to remove Sabina from Officer Bernatova's patrol vehicle. As Officer Bernatova was attempting to gain control of Sabina who was actively resisting again, I observed Sabina swing the handcuffs towards Officer Bernatova that was only secured on her left hand. Sabina struck Officer Bernatova's face above her lip.

As Sabina continued to actively resist Officer Bernatova and Officer Hansell, I grabbed onto Sabina due to Officer Bernatova actively bleeding above the left side of her lip. Sabina continued to resist me, Officer Hansell's and Sgt. Revoredo's lawful command to comply as Officer Hansell was attempting to place the hobble back onto Sabina's feet

due to her kicking it off. During this time, I observed Sgt. Revoredo attempting to gain compliance from Sabina using his agency issued AXON TASER. After several minutes attempting to resecure Sabina in handcuffs and a hobble, Sabina was properly secured and escorted back into the rear passenger side of Officer Bernatova's patrol vehicle.

After gathering pertinent information from Officers on scene, I transported Vlada to the Monroe County Detention Center. Prior to the transport and during the transport, Vlada removed her seatbelt multiple times.

Based on the facts and evidence of my investigation and actions of Vlada during my lawful duty, I believe there is probable cause that on 05/31/2023 Vlada Davidova violated F.S.S. 843.01 - Resisting Officer with Violence. Vlada knowingly and willfully resisted and obstructed Officer Roman by doing violence to her. At the time, Officer Roman was engaged in the lawful execution of a legal duty. At the time, Officer Roman was a Law Enforcement Officer. At the time, Vlada knew Officer Roman was an officer.

Vlada Davidova violated F.S.S. 784.07 - Battery on Law Enforcement Officer. Vlada actually and intentionally struck Officer Roman against her will. Officer Roman was a Law Enforcement Officer. Vlada knew Officer Roman was a Law Enforcement Officer. Officer Roman was engaged in the lawful performance of her duties when the battery was committed.

Vlada Davidova violated F.S.S 843.02- Resisting Officer Without Violence. Vlada resisted and obstructed Officer Roman by failing to proper identify herself at the request of Officer Roman.

At the time of this incident, I was on duty and in full Key West Police Department uniform, clearly identifiable as a Police Officer; based on the silver badge emblem that reads "Officer Key West Police FLA." above my left breast, "Key West Police" patches on each shoulder, and a silver pin on the right and left side of my collared shirt, that read "KWPD." I was operating my assigned, marked vehicle #4284. All of this took place in Key West, Florida.

My BWC and FLEET AXON were activated during this investigation. Nothing further to report.
