As required by the SFWMD Permit 48-01125-P, the sampling stations utilized in the Lake Davis Estates Fecal Coliform Monitoring Program are located at each of the outfall points of the permitted surface water system. These stations are located within an unnamed waterbody located on the central portion of the site (Station #1), within Lake Davis to the south (Stations #2, #3, and #4), and at the discharge point of a large forested wetland system which drains towards the north to Lake Butler (Station #5). The samples collected at these locations are obtained as surface "grabs" utilizing a polyethylene dipper.

Sample containers utilized in the laboratory analysis of samples are obtained from Test America, Inc. (DOH Certification #E83012 Orlando and DOH Certification #E84282 Nashville) prior to the sampling events. Once collected, all samples are placed on ice and stored at $\pm 4^{\circ}\text{C}$ until delivered to Test America, Inc. for analysis. Samples are delivered to the lab by the QAQC trained sampling biologist within three (3) hours of collection.

Avalon Park

The Avalon Park Development, located in east Orange County, Florida (Figure 1), is a Traditional Neighborhood Development (TND) which incorporates compact urban mixed development with a range of housing, shopping, and employment in close proximity to each other. Condition #19 of the Orange County Development Order issued for the project specified that a surface water quality monitoring program be implemented for the site to monitor the project's contributions to, and effects on surface water quality associated with the Econlockhatchee River and its tributaries. The water quality monitoring plan for the Avalon Park Development consists of quarterly collection of field data and surface water samples, as well as analysis of samples for specified parameters by an approved laboratory. Results of the quarterly monitoring events are compiled and outlined in annual reports that include comparisons of gathered data to State Water Quality Standards. In addition, data collected from the downstream station is compared to data collected at the upstream station to determine any significant changes as water passes through areas contributed to by the approved development. Quarterly monitoring is conducted until at least four (4) years after construction build-out unless the SJRWMD, with input from the OCEPD, determines that different sampling frequencies or time periods are appropriate and are identified in a permit issued to the Developer.

Field and laboratory investigations performed will utilize standard EPA and APHA procedures for collection and analysis of samples. Sampling procedures utilized during the collection of surface water samples are as outlined within "Standard Methods for the Examination of Water and Wastewater", APHA 17th ed. 1989 and within Section 6 of the analyzing laboratory's QAP.

Camino Reale

The Camino Reale Development of Regional Impact (DRI) Site is a 1,032.9-acre property located in south-central Orange County, within the Innovation Way Study Area. It is located south of Wewahootee Road and east of Lake Mary Jane Road, within Sections 1, 12, 13 and 24, Township 24 South, Range 31 East, Orange County, Florida (Figure 1). Wetlands/Surface waters associated with this DRI site, including areas associated with Roberts Island Slough, are hydrologically connected to Lake Mary Jane (a Class III Waterbody), as well as areas associated with the Econlockhatchee River (a Class III Waterbody and an Outstanding Florida Water).

As part of the DRI approval for the project, the developer, Camino Reale Properties, LLC, has implemented a program to monitor the quality of surface waters contributing to the area Class III waters. The data collected during this monitoring program will be utilized to document baseline conditions, and to compare subsequent conditions to background conditions, as well as calculated State water quality standards and Florida Department of Environmental Protection (FDEP) water quality indices, to determine the effects, if any, of development on the area surface waters.

In order to effectively monitor the project's potential effects on surface water conditions on and in the vicinity of the DRI site, the Developer or his successors, shall provide for the continued operation of the established surface water monitoring program which consists of the following components:

Surface water samples shall be collected within Roberts Island Slough, as well as at selected stormwater outfall points (once constructed), to help identify any effects of the development on area surface waters. In addition to Roberts Island Slough and the future outfall points, surface water samples shall be collected from the Disston Canal, at locations both up and downstream from the project site. The sampling within the Disston Canal will establish background conditions throughout the development project. These sampling locations were discussed with staff from the Orange County Environmental Protection Division (OCEPD) during a meeting

conducted on December 12, 2008. The locations were determined to be sufficient to assess the projects contributions to the water quality of the connected Class III waters. Sampling parameters were also agreed upon during this meeting.

Collection of surface water samples and field data is conducted two times annually on a seasonal basis prior to construction activities on the site. Once construction activities commence, and if deemed necessary, the collection of surface waters and field data will be increased to four times annually on a seasonal basis. The sampling period will extend at least three years following construction build-out of each phase of the project, unless it is determined by the interested regulatory agencies that the sampling frequency or time period can be reduced.

If, in the opinion of the interested regulatory agencies, the collected data are indicative of atypical conditions or violations of water quality standards or criteria, then the Developer, or his successors, shall incorporate additional water quality treatment and/or water management methods into the project's surface water management system to correct or mitigate any degradation. Any potential activities associated with corrective actions will be conducted in accordance with regulatory agency criteria through permit modification and coordination.
