A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S RIGHT OF WAY IMPROVEMENTS CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$91,054.00 TO INSTALL GRAVEL SHOULDERS ON DUCK AVENUE FROM 17TH STREET TO 18TH STREET AND ON THE 2600 BLOCK OF STAPLES AVENUE; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE DOCUMENTS UPON CONSENT OF THE CIY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 22-289, the City Commission awarded ITB #22-010, for Right of Way Improvements Contract, to provide paving services and sidewalk improvements, including removal and replacement of gravel shoulders, along City rights-of-way to Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of a Task Order to install gravel shoulders on Duck Avenue from 17th Street to 18th Street and on the 2600 Block of Staples Avenue to improve safety, drainage, and appearance; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's Right of Way Improvements Contract (ITB 22-010) with Charley Toppino & Sons, Inc. in a total amount not to exceed \$91,054.00, for installation of gravel shoulders on Duck Avenue from 17th Street to 18th Street and on the 2600 block of Staples Avenue, is hereby approved.

Section 2: That funding is budgeted for the Duck Avenue and 2600 Block of Staples Avenue shoulder improvements in Infrastructure Project account II41022203 - FY 23 Shoulder Replacement. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents for this project, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
