

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KW SONGWRITERS LLC DBA KEY WEST SONGWRITERS FESTIVAL TO CONDUCT A FREE CONCERT ON THE 200 BLOCK OF DUVAL STREET AND GREENE STREET BETWEEN FITZPATRICK & ANN STREETS ON MAY 7, 2022 FROM 7:00 P.M. TO 10:00 PM (SET UP AT 6:00 A.M AND BREAKDOWN MIDNIGHT.); GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FOR A CONCERT ON THE 200 BLOCK OF DUVAL STREET AND ADJACENT GREENE STREET FROM 7:00 P.M. TO 10:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, KW Songwriters LLC dba Key West Songwriters Festival wishes to conduct a street closure for a free concert on the 200 block of Duval Street between Duval & Greene Street between Fitzpatrick & Ann Streets.

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law.”

SECTION 2. That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic

utensils and “to go” packages for food or products sold on any property leased from the City

**SECTION 3.** KW Songwriters LLC dba the Key West Songwriters Festival is hereby granted permission to conduct a concert on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 4.** KW Songwriters LLC dba Key West Songwriters Festival will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash container will be used and that they will be placed side by side.

**SECTION 5.** KW Songwriters LLC. dba Key West Songwriters Festival is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
