## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ON POINTE ENTERTAINMENT TO HOLD THE IRISH KEVIN'S 5K/10K SHAMROCK SHUFFLE ON SATURDAY, MARCH 14, 2026, FROM 7:00 A.M. TO 12:00 P.M. (SETUP BEGINNING AT 6:00 A.M.) THROUGHOUT THE STREETS OF KEY WEST; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF SAID RACE FROM 6:00 A.M. TO 12:00 AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, On Pointe Entertainment wishes to conduct the "Irish Kevin's 5k/10k Shamrock Shuffle" beginning and ending at Irish Kevin's on Duval Street during the hours of 7:00 a.m. to 12:00 p.m. (setup beginning at 6:00 a.m.) on Saturday, March 14, 2026.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily

recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That On Pointe Entertainment is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place as herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, On Pointe Entertainment is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 5. That On Pointe Entertainment must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 6. That On Pointe Entertainment will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That On Pointe Entertainment pledges that proceeds will benefit MARC House and one other local organization to be

determined.

SECTION 8. That On Pointe Entertainment acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
