## RESOLUTION NO. 08-096

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AN ADJUSTMENT IN PUBLIC TRANSIT SYSTEM (BUS) FARES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the most recent adjustment to City bus fares was in 2003; and

WHEREAS, it is necessary from time to time to adjust fares, in light of increased operating expenses, and to maintain eligibility for federal and state grant funding;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the following adjusted fares for the public transit system are hereby authorized, effective April 1, 2008:

Regular Full Fare -- \$ 2.00

Regular 7-Day -- \$ 8.00

Section 2: That 31-day passes will remain at the current price of \$25.00 for regular fare, and \$15.00 for reduced fare.

Section 3: That 1-Day and 3-Day passes are hereby discontinued for the public transit system.

Section 4: That an hourly fee is hereby established for use of local transit services by private or non-profit organizations in the event commercial transit providers are unwilling or unable to provide comparable service, and/or in the interest of public safety. The fee shall be determined at the beginning of each fiscal year by dividing Transit Operations budget cost center 4402 by the total driving hours for city routes, and then adding 10% of that amount to determine the hourly rate. The hourly rate for FY 07-08 is \$60.

<u>Section 5</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
