

RESOLUTION NO. 19-322

A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), APPROVING ADDITIONAL LIGHTING AND DECORATIONS IN AN AMOUNT NOT TO EXCEED \$17,881.00 FROM BRANDANO DISPLAYS, INC. IN ACCORDANCE WITH THE CONTRACT AWARDED IN CRA RESOLUTION 18-216; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING NECESSARY BUDGET TRANSFER(S); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 18-216, the CRA awarded a three-year contract to Brandano Displays, Inc. in response to RFP 05-18; and

WHEREAS, at its meeting of September 18, 2019, the Key West Bight Management District Board recommended approval of additions and improvements to the holiday lighting plan, and an additional \$17,881.00 in funding for the 2019-20 holiday season under the contract to Brandano Displays, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That additional displays are hereby authorized in an additional amount not to exceed \$17,881.00 pursuant to terms contained in the CRA contract with Brandano Displays, Inc.

Section 2: That these additional displays are budgeted in budget account # 405-7504-575-4800, promotional expenses, and any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
