**TO: Expiring HOPWA Renewal Grantees and CPD Field Office Directors**

**RE: Fiscal Year 2013 HOPWA Permanent Supportive Housing Renewal Grant Application Guidance**

Enclosed please find a copy of the Fiscal Year 2013 HOPWA Permanent Supportive Housing Renewal Grant application notification and guidance. These materials outline the established procedures and standards for the submission, review, and approval of renewal funding for expiring HOPWA competitive grants that provide permanent supportive housing (PSH). The deadline for submitting a HOPWA renewal application is **January 29, 2013**.

One significant change for FY2013 is the availability of additional resources under the Resource Identification budget line item to assist your project to facilitate increased coordination with local Continuum of Care (COC) activities to more effectively address the housing needs of special needs populations. In addition, this guide provides for additional streamlining of the HOPWA renewal process by reviewing current performance shown: (1) the grantee's Annual Progress Report; and (2) HUD records for disbursements and management of these grants. Please reference Attachment A that summarizes changes to the application renewal processes, Attachment B lists the eligible renewal grantees and potential approvable budgets, and Attachment C provides for the standard HUD requirements that apply to competitive funds.

Please reference the chart provided below for those 32 grants eligible for renewal under this notice based on HUD records for expiration dates of current grant agreements (i.e., expiring dates falling between March 30,

2013 and April 30, 2014) and the currently known authorized grant representative. Please advise this office if some correction is needed on the point of contact or other items.

The Office of HIV/AIDS Housing requests that grantees inform HUD by email to this office if they are interested in applying under this streamlined renewal process and please provide the point of contact—grantees are asked to provide notification of their intent to seek renewal by sending an email to [Benjamin.L.Ayers@hud.gov](mailto:Benjamin.L.Ayers@hud.gov) or [Amy.L.Palilonis@hud.gov](mailto:Amy.L.Palilonis@hud.gov).
