### **New Case**

**Count 1:** Failure to hire a licensed contractor.- **Irreparable**

The Code Officer was Alma Montano. The Respondent Susan Glasser was present. Assistant City Attorney Ryan Waterhouse was present on behalf of the City. Officer Montano read her timeline and evidence was shown. Officer Montano testified that during a routine inspection on April 22, 2025, she observed construction activity involving the installation of a fence at the property. Upon investigation, two individuals identified as Saul Moreno and Silvino Moreno were found actively performing the work without proper licensing. A stop work order was issued on site.

Further investigation revealed that the permit for the fence (Permit No. BLD2025-0778) had been applied for but remained in an "incomplete application" status. The workers initially claimed to be hired directly by the homeowners, but later admitted to being employed by Philip Pop, part owner of Fabi's Fabulous Garden. Mr. Pop claimed the workers were recommended but hired directly by the homeowners; however, the workers' affidavits and statements confirmed they were sent by Mr. Pop to perform the work.

Officer Montano stated that the homeowners failed to provide any documentation verifying employment relationships, contractor licensing, or compliance with federal employment requirements under their homeowner's permit. Despite attempts by city staff to resolve the matter, communication with the respondents was limited. The same unlicensed workers reportedly completed the fence work after the homeowner permit was issued, without homeowner supervision on site as required. Assistant City Attorney

Ryan Waterhouse conducted direct examination of both the code officer and Ms. Glasser. Ms. Glasser acknowledged receiving advice and workers from Mr. Pop and that she and her husband did not directly communicate with the workers or verify their qualifications. She stated that she was unaware of the requirements and had not paid the workers or Mr. Pop. The Special Magistrate thought that there was substantial evidence for a finding of the violation and imposed \$250.00 administrative cost and \$1,000.00 Irreparable fine as well as getting an inspection for the un-permitted work within 30 days.

The Code Officer was Alma Montano. The Respondent Fabiola Asuaje was present. Assistant City Attorney Ryan Waterhouse was present on behalf of the City. This case was called as a companion matter to Case CCBLD 25-52 involving the homeowners at the same property. The Special Magistrate granted the City's request to adopt relevant testimony, affidavits, and photographic evidence from the previous case into the current record to expedite proceedings. Officer Montano read her timeline and evidence was shown. Officer Montano testified that on April 22, 2025, during inspection of

1706 Patricia Street, two individuals—Saul and Silvino Moreno—were found actively installing a fence. The men identified themselves as employees of Fabi's Fabulous Gardens, a landscaping business owned by Fabiola Asuaje and operated by her husband, Philip Pop. Mr. Pop initially claimed the workers were on vacation and had been hired directly by the homeowners. However, both workers provided sworn affidavits stating they were sent by Mr. Pop, were paid in cash for their work, and were acting on behalf of the company. The City presented a history of previous violations settled by Mr. Pop in April 2025 under Cases CCBLD 24-16, 25-26, and 25-32 for similar offenses. This current case was therefore cited as an irreparable repeat violation. Despite being advised of the violations and offered opportunities to respond, Mr. Pop and Ms. Asuaje repeatedly offered conflicting statements. Mr. Pop denied hiring the workers, denied involvement in the work, and made unsubstantiated claims about alleged corruption in the City. Ms. Asuaje later admitted that she asked her husband to deliver materials and directed the workers to assist the homeowners, but claimed no money was exchanged and it was intended as a favor. The affidavits from both workers, body cam footage, and statements from the homeowners contradicted the respondents' claims. Ms. Asuaje confirmed in the hearing that Saul and Silvino were her employees and had performed work at the property. The Special Magistrate thought that the testimony from Ms. Asuaje was invasive and not creditable. The Special Magistrate thought that there was substantial evidence for a finding of the violation and imposed \$250.00 administrative cost and \$2,500.00 for the Irreparable count for a total of \$2,750.00.
