#### THE FOX'S DEN

#### **Security Deposit**

A refundable security deposit of \$100.00 is required. The deposit is NOT applied toward rent; it is fully refundable within (14) days of departure, provided the following provisions are met:

- · No damage is done to unit or its contents, beyond normal wear and tear.
- No charges are incurred due to contraband or collection of rents or services rendered during the stay.
- · All furniture is replaced in original positions found during check-in.
- Both bicycles are locked under outside steps.
- All refuse and recyclables are placed in proper trash cans outside unit in common area. All kitchen wares are cleaned and returned to proper cabinets. Refrigerator is empty and cleaned. Range is clean, including oven.
- All remotes are returned to their original storage locations found during check-in.
- Both sets of keys are left on the dining table, all doors are locked during departure.
- No linens are damaged or lost. All dirty linens are left in shower stalls. There is not excessive laundry for number of occupants on your Booking Confirmation.
- One ceiling fan is left on on each level. Both air conditioners are turned OFF.

## **Cancellation Policy**

- No refunds of deposit or rental payments will be given if cancellation is received less than 30 days prior to scheduled arrival, unless owners can re-rent unit for exact dates.

### **Housekeeping Service**

There is no daily housekeeping service. It is the renter's responsibility to maintain a clean and orderly environment while residing in the property. There will be an end cleaning service performed after check-out. We do not permit bath and kitchen towels to be taken out of unit, but we do provide extra beach towels for your use.
