A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) AWARDING THE BID OF ONE SOURCE RESTORATION & BUILDING SERVICES, INC. IN RESPONSE TO ITB #21-014 IN A TOTAL AMOUNT NOT TO EXCEED \$694,553.00 FOR RE-BID CONCH REPUBLIC SEAFOOD COMPANY (CRSC) ROOF REPLACEMENT - KEY WEST HISTORIC SEAPORT (KB75021901); AUTHORIZING NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS IN CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 21-121 the City rejected bids for ITB #21-003 for Conch Republic Seafood Company Wall Cladding and Roof Replacement, because the proposals exceeded cost estimates, and unbalanced line item pricing; and

WHEREAS, the City re-bid the project as ITB 21-014, and two responses were opened on July 7, 2021. CRA/City staff found both bids to be responsive, and recommends award of bid to the lowest responsive bidder, One Source Restoration & Building Services, Inc.; and

WHEREAS, the Key West Bight Board approved this item at its meeting of July 14, 2021; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET
CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY,
AS FOLLOWS:

Section 1: That the bid of One Source Restoration &
Building Services, Inc. is hereby awarded in an amount not to
exceed \$694,553.00 in response to ITB #21-014 - RE-BID CRSC
Roof/Wall Cladding - Key West Historic Seaport, the terms and
conditions of which are incorporated herein.

Section 2: That funding for this project is budgeted
in Building Fund Account 405-7502-575-6200 (Project No.
KB75021901), a transfer from reserves in the amount of
\$465,000 is authorized to fully fund the project.

Section 3: That the City Manager is authorized to
execute any necessary documents, in conformance with the bid
documents, upon the advice and consent of the City Attorney.

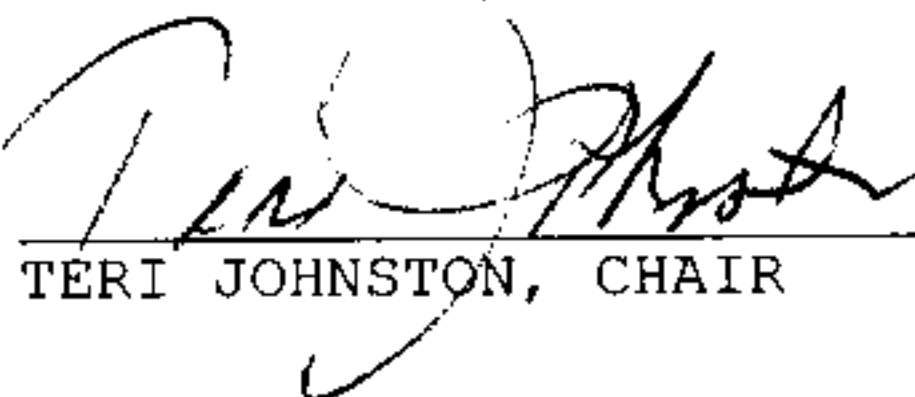
Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.

ACTION STATEMENT

Resolution approving award for Invitation to Bid (ITB) #21-014 - REBID: CRSC Roof / Wall Cladding – Key West Historic Seaport to One Source Restoration & Building Services, Inc., authorize the City Manager to execute the contract in the amount of \$694,553 and approving necessary budget transfer.

BACKGROUND

Conch Republic Seafood Company is an all metal structure in a highly corrosive environment. The roof on the structure is nearing the end of its useful life and the walkway overhang is experiencing heavy corrosion to both primary and secondary steel framing elements and need replacement. The wall cladding and wall girt are also experiencing heavy corrosion and are in need of repair/ replacement.

This project was previously advertised under ITB #21-003. Resolution #21-121 Rejected all bids in the best interest of the City on staff recommendation due to the unbalanced line item pricing received.

The Key West Bight Management District Board approved this item at their July 14, 2021 meeting.

PURPOSE & JUSTIFICATION

ITB #21-014 - REBID: CRSC Roof / Wall Cladding was advertised in June 2021 with 2 bids received on July 7, 2021. Both Bids were reviewed by staff and found to be responsive.

Key to the Caribbean – Average yearly temperature 77° F.

EXECUTIVE SUMMARY

It should be noted that material lead times may be an issue for completing the project in the specified months of August/ September. As with most construction materials, the COVID-19 Pandemic has had a major impact on the supply chain. Staff anticipates a minimum 12-week lead time once contract is awarded.
