A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE CONTRACT WITH FLORIDA KEYS EVR, LLC FOR "ASNEEDED" MAINTENANCE AND REPAIR SERVICES FOR THE KEY WEST FIRE DEPARTMENT FOR A TERM OF THREE (3) YEARS IN AN AMOUNT NOT TO EXCEED \$100,000.00 ANNUALLY, PURSUANT TO SEC. 2-797(4)b. OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY RELATED DOCUMENTS AND BUDGET TRANSFERS/ADJUSTMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Key West Fire Department provides life-saving emergency Fire/Emergency Medical Services ("EMS") for the City of Key West and relies upon the integrity and safety of its emergency Fire/EMS vehicles and apparatus to effectively and safely deliver these critical services; and

WHEREAS, due to the specialized and urgent nature of emergency Fire/EMS services, it is imperative that maintenance and repair services on emergency Fire/EMS vehicles and apparatus be performed by a skilled technician certified to work on emergency fire/medical services vehicles and apparatus; and

WHEREAS, the City does not have a certified Emergency Vehicle Technician on staff and Florida Keys EVR, LLC is the closest certified technician willing to travel to Key West to perform the exclusive and essential maintenance and repairs to the emergency Fire/EMS vehicles and apparatus for the Key West Fire Department; and

WHEREAS, Florida Keys EVR, LLC is willing to fulfill a need that is not otherwise available in the City of Key West, the Florida Keys or in South Florida; and

WHEREAS, Florida Keys EVR, LLC has proposed a Fee Schedule with "locked-in" rates, when used for maintenance and repairs, to be attached to, and made a part of, the contract as Exhibit A.; and

WHEREAS, pursuant to Sec. 2-797(4)b. of the Code of Ordinances of the City of Key West, Florida, City staff feels it is in the best interest of the City to enter into a contract with Florida Keys EVR, LLC to provide "as needed" maintenance and repairs on Key West Fire Department emergency Fire/EMS vehicles and apparatus in an amount not to exceed \$100,000.00 annually;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission hereby approves the attached contract with Florida Keys EVR, LLC effective upon execution and continuing for a term of three (3) years to provide "as needed" maintenance and repairs on Key West Fire Department Emergency Fire/EMS vehicles and apparatus, as set forth in Exhibit A. attached hereto and made a part hereof, in an amount not to exceed \$100,000.00 annually.

Section 2: That funds are budgeted and available in Accounts #001-2201-522-46-00 for Fire apparatus and #001-2601-526-46-00 for EMS apparatus.

Section 3: That the City Commission hereby authorizes the City Manager to execute any necessary related documents, administrative actions and budget transfers/adjustments, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
