

\$36,000.00 for two full time MDs and cross-coverage if necessary during sickness or leave.

The bulk of this cost goes towards our malpractice policy, and the remainder would be used for educational purposes with the EMS department, for example dinner lectures or practical exams.

Please note the attached Certificate of Insurance from The Doctors Company indicates a 250/750 claims-made policy for one person, and we have requested a quote from the same organization to cover a 1 million/3 million claims-made policy with wrapped-in tail coverage for two people. We do not have the specific quote from TDC yet but expect it to be in the \$10,000/yr range per physician.

In the Summer of 2011 IDM once again was asked to join in the final season of excavation at Kizilburun. This summer's objectives were fourfold: First, to lift the column drums to the surface and begin conservation for eventual display either at the Temple of Apollo in Claros, Turkey or at the Bodrum Museum of Underwater Archaeology; second, to begin scientific study of microparticles in the bloodstream before and after decompression diving; third, to begin a study of hyperoxic myopia in decompression diving; and finally, to complete a logistical study of the use of in-water recompression (IWR) as a bridge to definitive therapy in remote locations where formal hyperbaric chambers are not available. Personally completed 18 dives this year and assisted in preparations of drums for surface conservation. As referenced above, I was honored to represent the Explorers Club on this expedition by carrying flag # 172.

In January 2013 physicians from IDM assisted archaeologists from INA on preparatory excavations of a 1st century B.C. Hellenistic wreck off the coast of Godavaya, Sri Lanka. This wreck was likely transporting goods from the Mediterranean and with a stop-off in Sri Lanka, destined for the far East. This particular dive season was fraught with complications but no episodes of diving related illnesses. We plan on returning next January for a full excavation season. Again, it was my great honor to carry The Explorers Club flag #83 on this trip.

As an expert in diving expedition medicine, joined this committee to assist in expedition setup for members of The Explorers Club who need medical advice during certain situations, such as hyperbaric conditions, high altitude conditions, etc.

Explorers Club Flag expedition #132—Robert Walker Shipwreck Mapping project **May 2014-Present**

Acting as the dive medical officer for a joint expedition between The Explorers Club and NOAA, a flag expedition #132, a mapping project for the Robert Walker, an American Civil War era vessel sunk off the coast of Atlantic City, NJ in 1860. This wreck was a coast survey vessel, and twenty professional sailors died during its sinking. The Coast Survey was a parent organization of NOAA; thus, NOAA considers the men who lost their lives on this wreck to have died in service to both NOAA and our country and is thus pending "war grave" status.

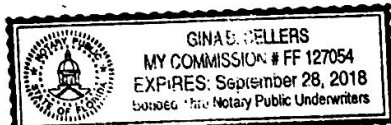
