**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING RICK'S & DURTY HARRY'S ENTERTAINMENT COMPLEX, INC. TO CONDUCT A SEAFOOD LOBSTER FESTIVAL ON SATURDAY, AUGUST 8, 2015, FROM 10:00 A.M. TO 12:00 MIDNIGHT, PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 100 , 200, 300 & 400 & 500 BLOCKS OF DUVAL STREET BETWEEN FRONT AND SOUTHARD STREETS INCLUDING THE GREENE STREET INTERSECTION AND TELEGRAPH LANE & CHARLES STREET FROM 10:00 A.M. TO 12:00 MIDNIGHT; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** Rick's & Durty Harry's Entertainment Complex wishes to conduct a Seafood Lobster Festival fundraiser for the Key West High School Scholarship Fund;

**WHEREAS,** other bars participating in the liquor extension are: Bagatelle, Hog's Breath, Conch Shack, Amigo's, Captain Tony's, Rumors Lounge, The Green Room, World of Beers, Scars & Tattoos, Sloppy Joe's, Lazy Gecko, Irish Kevin's, Johnny Rockets, BurgerFi, Fogarty's, Rick's/Durty Harry's, Smokin Tuna Saloon, Coyote Ugly, The Bull, Carolines, The Grand, Fat Tuesday, Hard Rock Café, the La Concha Hotel, Jack Flats, Willie T's, La Trattoria, and Margaritaville.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Rick's & Durty Harry's Entertainment Complex, Inc. is hereby granted permission to conduct a Seafood Lobster Festival on the day and during the hours stated above;

PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$2,000.00, whichever is greater shall be donated to the Key West High School Scholarship Fund.

**SECTION 2.** That Rick's & Durty Harry's Entertainment Complex is hereby granted permission for the closure of Duval Street between Front and Southard Streets and including Greene Street between Ann and Telegraph Lane & Charles Street on the date and during the hours stated above.

**SECTION 3.** That Rick's & Durty Harry's Entertainment Complex, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Rick's & Durty Harry's Entertainment Complex, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** Rick's & Durty Harry's Entertainment Complex, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and

adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
