A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION GRANT AGREEMENT" (PTGA) BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR SFY2026 PARK AND RIDE LOT PROGRAM FUNDING ASSISTANCE FOR THE PARK AND RIDE GARAGE IN AN AMOUNT NOT TO EXCEED \$800,000; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS AND NECESSARY BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 25-138, the City Commission authorized certain City staff to apply for grant funding and to execute and submit grant documentation through the Federal Transit Administration (FTA) and Florida Department of Transportation (FDOT); and

WHEREAS, funding through the FDOT Park and Ride Lot Grant Program, provides State assistance for expenses of the Park and Ride Garage of up to \$1,600,000 or \$800,000 (50% State/50% City); and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" (FM #455226-1-94-01) is hereby approved, between FDOT and the City, for Park and Ride Lot Program funding assistance for repairs, maintenance, and improvements to Park and Ride Garage in an amount not to exceed \$800,000 (50% of total project cost of \$1,600,000.00).

Section 2: That the City Manager is authorized to execute any and all other documents, including amendments, renewals, and extensions, subject to all allocation, and appropriations in accordance with such grant, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
