A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER FOR CONSTRUCTION PHASE SERVICES FOR THE AQUARIUM SEAWALL REPAIR PROJECT BY TETRA TECH, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$113,207.00, UNDER THE CITY'S ENVIRONMENTAL ENGINEERING SERVICES CONTRACT, AS AMENDED; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS/AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-359, the City Commission approved a three-year Environmental Engineering Services contract with Tetra Tech, Inc., in Resolution 17-299 the contract was extended for two years, and in Res. 17-302 an Addendum to contract to Facilitate FEMA Reimbursement was approved; and

WHEREAS, under Resolution 18-057, Tetra Tech provided planning, engineering, design and permitting services to repair the Irma-damaged seawall at the Key West Aquarium, and at City staff's request, Tetra Tech prepared a fee proposal to provide required inspection and additional engineering services during construction; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached Task Order for construction phase services for the Aquarium Seawall Repair Project under the City's Environmental Engineering Services Contract with Tetra Tech, Inc., is hereby approved in an amount not to exceed \$113,207.00.

Section 2: This project will be funded from account No. 001-1910-519-6500, Project No. HU1701E01, and any necessary budget amendments/transfers are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
