A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER TO CHARLEY TOPPINO & SONS, INC. IN AN AMOUNT NOT TO EXCEED \$95,146.63 FOR THE REPAIR AND REPLACEMENT OF DAMAGED 8 INCH POTABLE WATER SERVICE MAIN AT THE RICHARD A. HEYMAN ENVIRONMENTAL PROTECTION FACILITY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 21-125, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc.; and

WHEREAS, staff has identified a section of damaged 8" potable water service main at the Richard A. Heyman Environmental Protection Facility; and

WHEREAS, the damaged section of 8" pipe is currently reduced to a 2" service; and

WHEREAS, the repair and restoration of the damaged 8" potable water service main will restore the functionality of the wastewater treatment plant's operations;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Task Order from Charley Toppino & Sons, Inc. for the Repair of Damaged 8" Water Main is hereby approved in the amount not to exceed \$95,146.63.

Section 2: That this project is budgeted in Sewer Fund/Renewal and Replacement 401-3503-535-6500 Construction in Progress and any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
