A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ESTABLISHING A SELECTION COMMITTEE FOR THE KEY WEST SCULPTURE GARDEN MEMORIAL; PROVIDING CRITERIA FOR MEMBERSHIP ON THE SELECTION COMMITTEE; PROVIDING CRITERIA FOR NOMINATION AND APPROVAL OF THE MEMBERS OF THE SELECTION COMMITTEE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to Resolution 95-468, the City Commission established the Key West Sculpture Garden Memorial; and

WHEREAS, the City Commission desires to appoint a selection committee with lifetime tenure whose task it will be to determine those persons to be included in the Memorial;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That a Key West Sculpture Garden Memorial selection committee is hereby established;

<u>Section 2</u>: That criteria for the selection committee is hereby established as follows:

 A member shall have demonstrated an extensive and ongoing interest and knowledge of the history of Key West; 2. A member shall be at least 40 years of age;

- 3. A member shall agree to a lifetime appointment;
- 4. A member shall have had residency in Key West for at least 15 years;
- 5. A member shall have demonstrated an interest in Key West history by: a) having written on the subject, b) having served on a preservation or historic committee of the City, c) having been involved in preservation, rehabilitation or construction efforts relating to historic structures; and/or d) being considered by his or her peers to be an expert in Key West history and folklore;

Section 3: That the Mayor is hereby authorized to obtain information on potential nominees and then to nominate nine members to the selection committee who shall be appointed upon the approval of the entire City Commission within sixty (60) days of this Resolution.

<u>Section 4</u>: That vacancies on the selection committee shall be filled according to the procedure set forth in Section 3.

Section 5: That within thirty (30) days of appointment, the selection committee shall hold its first meeting and elect a

chairperson.

Section 6: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
