An application was received requesting the removal of **(1) Autograph and (1) young Spanish Lime tree**. A site inspection was done and documented the following:

Tree Species: Autograph (Clusia sp.)

Location: 90%

Species: 100% (on protected tree list)

Condition: 10% (main part of tree is mostly dead. Tree heavily damaged in Hurricane Irma)

Total Average Value = 66%

Value x Diameter = 5.8 replacement caliper inches

Tree Species: Spanish Lime (*Melicococcus bijugatus*)
