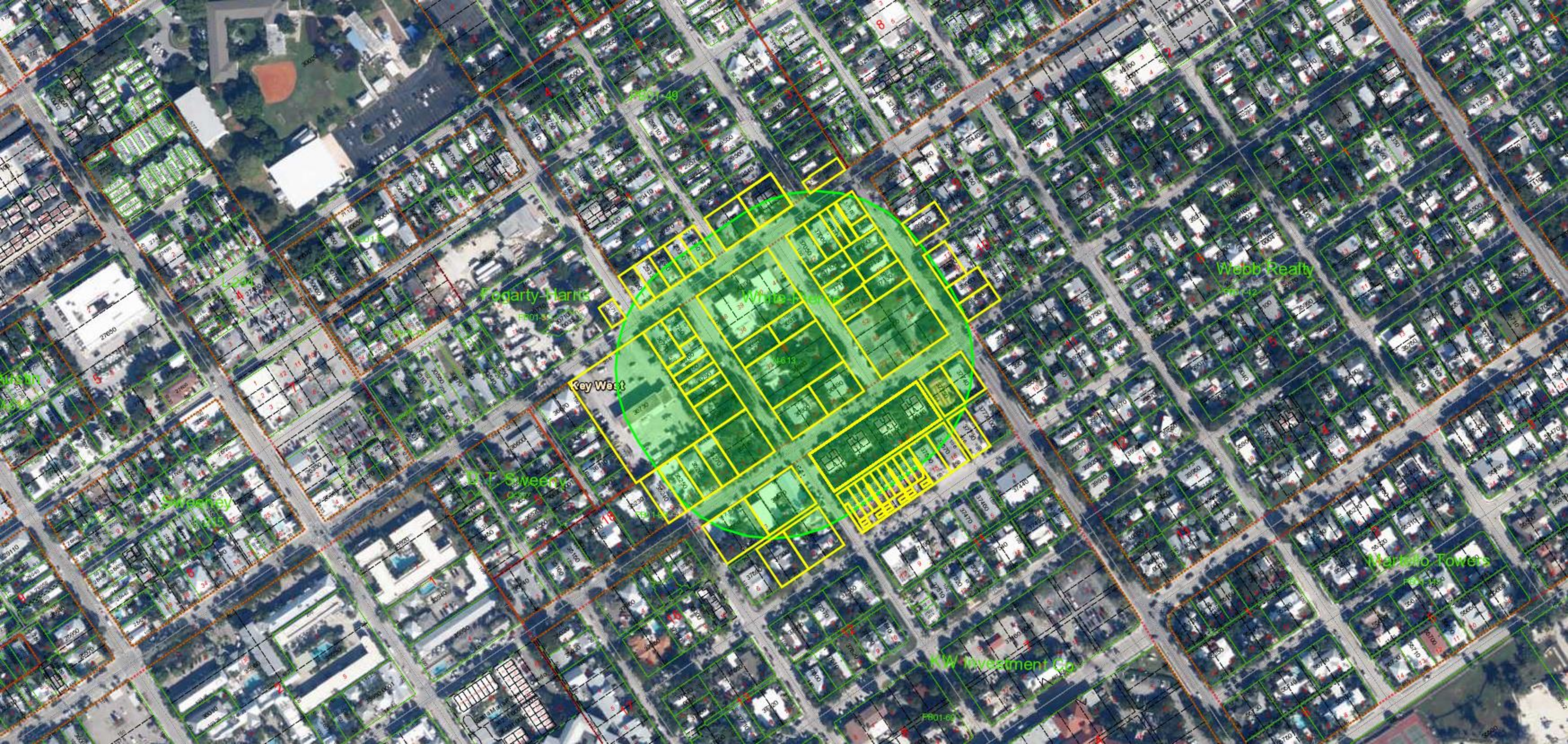

The City of San Francisco has adopted a new ordinance that will require all new buildings to be constructed with a minimum of 10% green roof area. This ordinance is intended to reduce the city's carbon footprint and improve air quality. The ordinance will apply to all new buildings over 10,000 square feet. The ordinance will also require that the green roof area be used for a variety of purposes, including growing food, reducing stormwater runoff, and improving air quality.
