A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$175,000.00 FOR ATLANTIC BOULEVARD MULTI-USE PATH DRAINAGE AND SAFETY ENHANCEMENTS; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc., in Resolution No. 18-014 the Contract was amended to incorporate certain Federal Contracting provisions, and in Resolution 18-322 the contract was renewed for two years; and

WHEREAS, drainage and safety enhancements to the Atlantic Blvd multi-use path from Rest Beach to Bertha Street will serve as an interim solution to protect public safety until Monroe County develops and executes plans to raise the heavily-used roadway and pathway adjacent to Bertha Street, anticipated in FY 20/21; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's General Utilities Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$175,00.00, for Atlantic Boulevard Multi-Use Path Drainage and Safety Enhancements is hereby approved.

Section 2: That this project will be funded from Internal Improvements (Gas Tax)/Streets/Capital Improvements Account No. 102-4102-541-6300, Project II41021802 (Paving). Any necessary budget adjustments are authorized.

Section 3: That the City Manager is authorized to execute any necessary documents for this Task Order, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
