A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER TO ARTIBUS DESIGN, LLC FOR THE DESIGN OF PERMANENT REPAIRS FOR THE FLEMING KEY UTILITY BRIDGE IN AN AMOUNT NOT TO EXCEED \$74,520.00; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS IN SUBSTANTIAL CONFORMANCE WITH THE TASK ORDER, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 17-207, the City Commission awarded a contract on a task order basis to Artibus Design, LLC for General Engineering Services; and

WHEREAS, on April 22nd, a barge navigating the Fleming Key Cut lost control and collided with the City's utility bridge, which supports the City's two influent force mains, as well as the Wastewater Treatment Plant's electric and water supply lines; and

WHEREAS, the impact compromised two pilings, and the City pursuant to an emergency procurement, engaged Artibus Design, a local structural engineering firm, to design emergency repairs on April 23rd; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That a task order to Artibus Design, LLC, for design of permanent repairs to the Fleming Key utility bridge, is hereby approved in an amount not to exceed \$74,520.00.

Section 2: That this task order will be paid from budget line Sewer/Treatment Plant/Capital Improvements Account No. 401-3504-535-6500, Project SE35041904, and any necessary transfers from reserves are hereby authorized. The City is attempting to subrogate costs from the party at fault.

Section 3: That the City Manager is hereby authorized to execute necessary documents, upon advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
