A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AMENDING RESOLUTION 15-233 TO INCLUDE THE 800 BLOCK OF EMMA STREET DURING GOOMBAY 2015 ON FRIDAY, OCTOBER 23 AND SATURDAY OCTOBER 24, 2015 FROM 12:00 NOON TO 12:00 MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 12:00 MIDNIGHT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Key West Goombay Festival, Inc has requested an amendment to resolution 15-233 to include the 800 block of Emma Street.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida;

SECTION 1. That the Key West Goombay Festival, Inc. is hereby granted permission for the amended resolution during the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Goombay Festival, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 3. That pursuant to resolution number 15-233, the 800 block of Emma Street has been added.

SECTION 4. That the Key West Goombay Festival, Inc. will adhere to the recycling plan of the City of Key West.

SECTION 5. That the Key West Goombay Festival, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West of Ordinances for an event that will take place and time herein described.

SECTION 5. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
