A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF REYNOLDS CONSTRUCTION, LLC dba REYNOLDS CONSTRUCTION OF FLORIDA, LLC RECEIVED IN RESPONSE TO INVITATION TO BID (ITB) #23-007 FOR RICHARD A. HEYMAN ENVIRONMENTAL PROTECTION FACILITY RAS AND WAS PUMP SYSTEM REPLACEMENT PROJECT IN A TOTAL AMOUNT NOT TO EXCEED \$3,600,000.00; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West owns, maintains and operates the Richard A. Heyman Environmental Protection Facility (RAHEPF); and

WHEREAS, the Return Activated Sludge and Waste Activated Sludge (RAS/WAS) system has entered the end of its useful life and must be replaced and

WHEREAS, one bid was received from Reynolds Construction, LLC in response to ITB 23-007, for Richard A. Heyman Environmental Protection Facility RAS and WAS Pump System Replacement Project, and City staff determined the bid to be responsive and responsible; and

WHEREAS, City staff accordingly recommends that the City Commission award the bid to Reynolds Construction, LLC in response to ITB 23-007.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Reynolds Construction, LLC is hereby awarded in response to ITB 23-007 for Richard A. Heyman Environmental Protection Facility RAS and WAS Pump System Replacement Project, in an amount not to exceed \$3,600,000.00.

Section 2: That the project is budgeted in Sewer Fund 401-3504-535-6500, Project #SE35042102. Any additional necessary budget transfers, adjustments or amendments are hereby authorized.

Section 3: That the City Manager is authorized to execute a contract in substantial conformance with the bid documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
