#### Narrative

NARRATIVE OF INCIDENT

Bender was a passenger in a vehicle that was stopped due to the driver's reckless operation of the car. Upon the vehicle coming to a stop, Bender exited the vehicle and walked away. Officer Florez instructed Bender not to leave and directed him to return to the car. Bender disregarded the lawful

command and began to act animatedly, waving his arms in front of Officer Flores and yelling. He approached Officer Flores aggressively, jumping in front of her and entering her reactionary gap, compromising her Officer safety.

Officer Flores gave multiple verbal commands for Bender to cease his behavior and step back.

Despite these commands, Bender continued to approach in a hostile manner. Officer Lopez intervened and utilized a leg sweep takedown technique to bring Bender to the ground. Bender was immediately secured in handcuffs without further incident.

As a result of the takedown, Bender sustained a contusion to his forehead and abrasions to his right knee. He was transported to Lower Keys Medical Center, where he was medically evaluated and cleared. I responded to the scene and spoke with the Bender. He did have a contusion to his forehead and a scrape to his right knee. I photographed his injuries, he was uncooperative and did not complain of any injuries.

I spoke to David Reeves who is an out of county LEO. He was standing next to the incidenr when it happened. Officer Gruba took his statement Reeves saw Bender acting aaggressively towards Officer Flores and Officer Lopez. as Bender was on the ground Reeves assisted Officers in holding Benders legs down until other Officer came to assist.
