A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A.H. OF MONROE COUNTY, INC. TO CONDUCT THE CORONATION OF THE KING & QUEEN OF FANTASY FEST AT THE SOUTHERNMOST BEACH CAFÉ AT 1405 DUVAL STREET ON FRIDAY, OCTOBER 17, 2014 FROM 9:00 A.M. TO 12:00 MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 6:00 P.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, A.H. of Monroe County, Inc. wishes to conduct the Coronation of the King & Queen of Fantasy Fest.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That A.H. of Monroe County, Inc. is hereby granted permission to conduct the Coronation of King & Queen of Fantasy Fest on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meets the terms and conditions set forth by the City Manager.

SECTION 2. That A.H. of Monroe County, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 3. That pursuant to Section 18-86 of the Key West Code of Ordinances, A. H. of Monroe County, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 4. That A. H. of Monroe County, Inc. will adhere to the recycling plan of the

City of Key West, That one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 5. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
