A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES & INFRASTRUCTURE SERVICES CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$277,905.63 FOR THE TRUMAN WATERFRONT GRASS LOT GRAVEL RESURFACING; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 21-125, the City Commission awarded ITB #21-007 for General Utilities & Infrastructure Services Contract to Charley Toppino & Sons, Inc.; and

WHEREAS, in Resolution 22-195, the City Commission approved Tourist Development Council grant for \$200,000.00 for Key West Amphitheater Enhancements Phase II; and

WHEREAS, City staff recommends approval of a Work order for gravel resurfacing at the grass lot located at Truman Waterfront Park across from Coffee Butler Amphitheater to reduce impacts and maintenance; and

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE
CITY OF KEY WEST FLORIDA, AS FOLLOWS:

Section 1: That the attached work order in the amount
of \$277,905.63 under the contract awarded to Charley Toppino
and Sons, Inc. in Resolution 21-125, for Truman Waterfront
Gravel Resurfacing project is hereby approved.

Section 2: That funds for the Task Order are
allocated in account #101-4303-543-6300 up to \$278,000.00.

Section 3: That the City Manager is authorized to
execute documents related to this Task Order, upon the advice
and consent of the City Attorney.

Section 4: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication
by the signature of the Presiding Officer and the Clerk of the
Commission.
