ORDINANCE NO.

AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 2 OF THE CODE OF ORDINANCES, ENTITLED *"UNIFORM* PROCEDURES FOR ADVISORY BOARDS", BY AMENDING ARTICLE V ENTITLED "COMMITTEES, BOARDS AND COMMISSIONS" AND BY 2 AMENDING DIVISION TITLED "UNIFORM PROCEDURES FOR ADVISORY BOARDS" BY ADDING SCREENING COMMITTEES, BY AMENDING SECTION 2 - 281ENTITLED "APPLICATION", BY SECTION 2-282 AMENDING ENTITLED "APPOINTMENT; TENURE" TO PROHIBIT MEMBERS OF THE CITY COMMISSION FROM SERVING ON ADVISORY BOARDS OR SCREENING COMMITTEES AND TO PERMIT FOR DIRECT REMOVAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, from time to time, the City Commission for the City of Key West creates screening committees for the purpose of hiring a new city manager, city attorney, and city clerk pursuant to Secs. 2-143, 2-150, 2-160, and;

WHEREAS, the City Commission for the City of Key West determines by a majority vote whether to create a screening committee to vet candidates for such positions, and;

WHEREAS, the City Commission for the City of Key West determines that allowing a sitting member of the city commission to serve on advisory board or screening committee created by the city commission would thwart the intent of the majority of the city commission to create such a board NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:

Section 1: That Article V, Division 2 Section 2-281 is hereby amended in the Code of Ordinances as follows*:

DIVISION 2. - UNIFORM PROCEDURES FOR ADVISORY BOARDS AND SCREENING COMMITTEES

Sec. 2-281. - Application.

Except as otherwise provided in this Code and in the land development regulations and excepting the city commission, this division shall be designated as the uniform procedures for the city's advisory boards <u>and screening committees</u>, including those boards designated as commissions.

<u>Section 2</u>: That Article V, Division 2 Section 2-282 is hereby amended in the Code of Ordinances as follows*:

Sec. 2-282. - Appointment; tenure.

All persons who desire to serve on an advisory board shall be city residents, except as provided in section 46-62 of this Code or as otherwise provided by law. <u>All requirements for members</u> who serve on a screening committee shall be established by the *(Coding: Added language is underlined; deleted language is struck through at first reading. Added language is double underlined and double struck through at second reading.)

<u>resolution of the city commission creating such a committee. No</u> <u>member of the city commission may serve on an advisory board or</u> <u>screening committee.</u> All such persons shall submit a resume to the <u>appointing member of the city commission as part of their</u> application. All directly appointed advisory <u>and screening</u> board members serve at the pleasure of their appointing city commissioner. The city commission may remove an advisory board member, whether directly appointed or appointed by the vote of the commission, by majority vote of its full membership No member derives any property rights in their appointed position.
