**A RESOLUTION OF THE CITY COMMISSION OF
THE CITY OF KEY WEST, FLORIDA,
AUTHORIZING A \$35,000.00 EXPENDITURE TO
A POSITIVE STEP OF MONROE COUNTY, INC.
FOR THE "IDLE HANDS SUMMER YOUTH
EMPLOYMENT PROGRAM"; AUTHORIZING
NECESSARY BUDGET TRANSFERS AND
ADJUSTMENTS FROM GENERAL FUND RESERVES;
PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the City of Key West has supported the Idle Hands Summer Youth Employment Program through A Positive Step of Monroe County, Inc. since 2011; and

WHEREAS, during budget preparations for FY 20-21, the City of Key West did not fund certain non-profit programs, due to anticipated revenue reductions related to the Covid-19 Pandemic; and

WHEREAS, as 2021 begins there is reason to expect the City's economic position will continue to improve in the coming months; and

WHEREAS, the City Commission finds that the Idle Hands Summer Job Training Program provides local youth with training for city jobs, and participants gain employment experience that benefits the City and the students alike; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a \$35,000.00 grant is hereby authorized by the City Commission for A Positive Step of Monroe County, Inc. for the Idle Hands Summer Youth Employment Training Program.

Section 2: That funding for this grant will be allocated from General Fund Reserves account 001-1900-519.9803, to cover up to 50% of the total program costs, an amount not to exceed \$35,000.00. Any necessary budget transfers and adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
