A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF CHARLEY TOPPINO AND SONS, INC. FOR DONALD AVENUE EMBANKMENT STABILIZATION, INCLUDING LINDA AVENUE EMBANKMENT RIPRAP, IN ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 15-010, IN AN AMOUNT NOT TO EXCEED \$50,912.00; AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE AND UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on April 29, 2015 two bids were opened in response to ITB #15-010, for Donald Avenue Embankment Stabilization including Linda Avenue Embankment Riprap, and the bids were determined to be responsive; and

WHEREAS, City staff recommends award of the bid to the lowest responsive bid, by Charley Toppino and Sons, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Charley Toppino and Sons, Inc. for Donald Avenue Embankment Stabilization including Linda Avenue Embankment Riprap in accordance with the terms specified in ITB #15-010 is hereby awarded in an amount not to exceed \$50,912.00.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
