Subject: Approval of Amendment to the Task Order with Calvin, Giordano & Associates Inc. (CGA) for additional design services for the Wicker Sports Complex Transportation Improvements Project

ACTION STATEMENT

Approve Amendment to Task Order with Calvin, Giordano & Associates Inc. (CGA) for additional design services for the Wicker Sports Complex Transportation Improvements Project. Authorize the City Manager to execute this agreement and any necessary budget transfers/amendments.

BACKGROUND

CGA was issued a purchase order for design services in the amount of \$150,210.00 for the preparation of plans and design associated with Wicker Sports Complex Bicycle Route Alignment in support of the Crosstown Greenway and the 2019 Bicycle Pedestrian Master Plan (BPMP). The design services were authorized by Resolution 21-140 and CGA was procured under the general traffic engineering services agreement authorized by Resolution 18-143 and extended for a two-year period per Resolution 21-063.

During the design process it was revealed that modifying the parking plan for the greater complex would lead to an overall improvement in the park. Additionally, in the original scope, required drainage improvements to the west-side parking lot contributed to an inflation of the total cost and extension of the project timeline. A new design that takes into account site modifications to accommodate anticipated improvements for Fire Station #3 will provide safer connectivity for cyclists along the Crosstown Greenway adjacent to Poinciana Elementary in addition to improved restroom, athletic, and skatepark facilities.

PURPOSE AND JUSTIFICATION

This project supports the *Key West Strategic Plan, Priority 6: Traffic & Pedestrian Friendliness*.
