-- Caleb Allan Kjenaas Arrest Narrative:

On 04/30/2025, at approximately 0346 hours, I, Ofc. Gruba, was dispatched to 419 Truman Ave, upstairs unit, in reference to a male knocking on the door and attempting to get into the residence.

Upon arrival, I met the male, later identified as Caleb Kjenaas, attempting to get into the residence. I told Kjenaas he was not at the right address. I asked Kjenaas where he was staying. Kjenaas was not able to tell me where he was staying. I asked Kjenaas multiple times for identification. Kjenaas tried to give me multiple different credit cards. Eventually, we were able to find two different identifications cards in Kjenaas purse. One of the ID cards was out of New Jersey, supposedly issued to David Pinkard, DOB 03/28/2003. The other one was out of Texas, issued to Caleb Kjenaas, DOB 03/28/2005. Ofc. M. Hansell took both ID cards and ran them. The ID card issued to

Upon Ofc. Hansell's return and informing me of the fake ID card. I told Kjenaas to turn around and place his hands behind his back. Kjenaas turned around and ran across the porch of the downstairs unit at 419 Truman Ave. I pursued Kjenaas and tackled him. Our momentum took us over a porch swing and the railing. Kjenaas and I landed on the gravel ground, with Ofc. Hansell right behind. Ofc. Hansell and I attempted to get Kjenaas' hands behind his back through verbal commands and physically trying to get them from underneath him. Ofc. Lopez arrived and Kjenaas was still reluctant to put his hands behind his back. I told Kjenaas if he did not put his hands behind his back, he would get tased. Kjenaas still resisted our commands. I performed a "drive stun" on Kjenaas' left side of his mid-back. Kjenaas soon after, gave us both hands and I was able to place Kjenaas in handcuffs.

Kjenaas sustained some abrasions to the right ear. Kjenaas was brought to the ER by Key West Rescue 2 reference EMS run 25-2343. Kjenaas was evaluated and cleared at the ER. Kjenaas was brought to Monroe County Detention Center by Ofc. Lopez.

Caleb Kjenaas violated Florida State Statute 322.212-1A, Unauthorized possession of blank / forged / stolen DL. Kjenaas knowingly had in his possession a forged, fictitious, counterfeit, or unlawfully issued driver license or identification card or any instrument in the similitude of a driver license or identification card.

Caleb Kjenaas violated Florida State Statute 843.02, Resist officer without violence. Kjenaas resisted, obstructed, opposed my lawful commands to place his hands behind his back, followed by running away from me, followed by refusing to put his hands behind his back. At the time I was an officer at Key West Police Department and engaged in the lawful execution of a legal duty. At the time Kjenaas knew I was an officer due to my class "B" uniform and patrol vehicle.

My BWC was activated.

On 04-30-25, I K-9 Ofc. M. Hansell along with Ofc. J. Gruba responded to 419 Truman Ave unit F in reference to a suspicious person.

Key West Dispatch advised a caller stated a male was knocking on their door and trying to get inside. The male was described as wearing black clothing with a baseball cap on backwards.

Upon arrival, Ofc. Gruba was on the second-floor outer balcony that faces Truman Ave. looking for the male as I made my way up the stairs on the East side of the building.

Ofc. Gruba had made contact the male as he walked toward the East stairs and obtained his identification consisting of two licenses out of New Jersey and Texas. We walked the male, later identified as Caleb Kjenaas to the bottom of the stairs and I had him sit on the steps leading to the front porch of the property.

I took both ID's and went back to my patrol vehicle and entered both ID's in NCIC/FCIC. The Texas ID came back to the male, later identified as Kaleb KJenaas. The New Jersey license came back not on file and is most likely a fake.

I returned to Ofc. Gruba and KJenass, who were giving Ofc. Gruba conflicting statements as to who he was and where he was staying. Ofc. Gruba told Kjenaas to stand up as he was going to place him in custody.

Kjenaas stood up taking a step back on the steps before turning and running away from us across the front porch of the Airbnb. Ofc. Gruba and I chased Kjenaas with Ofc. Gruba grabbing ahold of Kjenaas as he attempted to jump over the West railing. I watched as both Ofc. Gruba and Kjenaas went headfirst over the rail onto the driveway.

I jumped over the rail as well landing on top of Ofc. Gruba and Kjenaas. Kjenaas was attempting to push up away from me and Ofc. Gruba and I while tucking his hands underneath his body. I reached across Kjenaas chest with my left hand and attempted to pull Kjenaas away from the side of the building. Kjenaas rolled back toward the building and pulled himself tighter. I then applied a pressure point to the back of Kjenaas left ear with my thumb while telling him to stop resisting. I kept pressure on Kjenaas as Ofc. Gruba and Ofc. Lopez placed Kjenaas into handcuffs.

I advised Channel one that we had one in custody and requested a supervisor to the scene. Sgt. Del Valle and Sgt. Stutz arrived, and I explained my portion of the incident. As a result of the incident, I had three small scrapes on my left shin as a result. Sgt. Del Valle took photos of my injuries, and I remained on scene until Kjenaas was transported by Ofc. Lopez.

Narrative

NARRATIVE OF INCIDENT

On April 30, 2025, at approximately 0346 hours, Officers Gruba and Hansell responded to 419 Truman Avenue regarding a report of an intoxicated individual attempting to enter a residence. The resident advised dispatch that a male subject knocked persistently and tried to open the front door.

Upon arrival, officers located the subject on the second-floor porch of the residence and walked him down to the first-floor porch. They identified him as Caleb Kjennas. Kjennas appeared to be highly intoxicated. When asked for his Identification, he gave Officer Gruba a fake ID card. While on the 5' elevated porch, Kjennas fled on foot. Officer Gruba pursued, and he and Kjennas fell over the porch railing onto the ground below. Officer Hansell then jumped over the railing to assist.

As Kjennas continued to resist arrest, Officer Gruba delivered two drive-stuns with his Taser 7 to Kjennas's left mid-back area. Simultaneously, Officer Hansell applied a pain compliance technique using a thumb press to Kjennas's right ear lobe. Kjennas ceased resisting immediately and was successfully handcuffed without further incident.

I spoke to the suspect, who was identified as Kjennas. I asked him if he was injured, and he said no. I observed a small amount of blood on the right side of his face next to his right ear.

Key West Fire Rescue responded to the scene to evaluate Kjennas. He complained of pain in his left elbow and stated it was due to a previous injury from a fall. Kjennas signed a medical refusal with rescue personnel.

Officer Lopez then transported Kjennas to Lower Keys Medical Center, where he was medically cleared.

Officer Gruba received abrasions to both of his knees, and Officer Hansell received abrasions to his left shin. Officer Gruba went to Lower Keys Medical Center and was treated for abrasions to his knees.

All injuries were documented with photos.
