A RESOLUTION OF THE KEY WEST BIGHT MANAGEMENT RATIFICATION BOARD APPROVING PURCHASING ORDINANCE EXEMPTION FOR A CHANGE ORDER TO TEMPORARY PRIVATE SECURITY SERVICES CONTRACT, FOR THE KEY WEST HISTORIC SEAPORT AND CITY MARINA ATGARRISON BIGHT, FLORIDA KEYS SECURITY LLC IN THE AMOUNT \$75,000 FOR TOTAL CONTRACT AMOUNT Α TO EXCEED \$125,000 PURSUANT TO SEC. 2-797 THE CITY OF KEY WEST CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Florida Keys Security LLC was issued a temporary private security services contract in April 2025; and

WHEREAS, a change order was required to maintain private security services until a new contract can be approved; and

WHEREAS, pursuant to Sec. 2-797 of the City of Key West Code of Ordinances the City Manager executed a Purchasing Exemption on June 6, 2025 for a change order to the temporary private security services contract at Key West Historic Seaport and City Marina at Garrison Bight; and

NOW, THEREFORE, BE IT RESOLVED BY THE KEY WEST BIGHT MANAGEMENT DISTRICT BOARD, AS FOLLOWS:

Section 1: That pursuant to Sec. 2-797 of the Code of Ordinances, the Key West Bight Management District Board recommends Purchasing Exemption ratification for change order to temporary private security services contract to Florida Keys

Security LLC, in the amount of \$75,000, for a total contract not to exceed \$125,000 as executed by the City Manager on June 6, 2025.

Section 2: Funds are available in the Key West Bight Fund 405 (\$51,000) for the Key West Historic Seaport and the Garrison Bight Fund 413(\$24,000) for the City Marina at Garrison Bight.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
