A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST BUSINESS GUILD TO CONDUCT A MIXER KICK OFF TOYS FOR TOTS DRIVE EVENT ON WEDNESDAY, NOVEMBER 10, 2010 FROM 2:00 P.M. TO 10:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 900 BLOCK OF FLEMING STREET BETWEEN MARGARET & GRINNELL STREETS; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 P.M. TO 10:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

**SECTION 1.** That Key West Business Guild is hereby granted permission to conduct a fundraiser on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and 25% of gross revenue or \$1,000.00, whichever is greater shall be donated to the Key West Police Department Holiday Toy Drive.

**SECTION 2.** That the Key West Business Guild is hereby granted permission for the closure of Fleming Street between Margaret & Grinnell Streets on the date and during the hours stated above.

SECTION 3. That the Key West Business Guild is hereby granted a Special Event

Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Business Guild is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 5.** That the Key West Business Guild will adhere to the recycling plan of the City of Key West.

**SECTION 6.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
