A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST BUSINESS GUILD TO CONDUCT A MIXER KICK OFF TOYS FOR TOTS DRIVE EVENT ON WEDNESDAY, NOVEMBER 10, 2010 FROM 2:00 P.M. TO 10:00 P.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 900 BLOCK OF FLEMING STREET BETWEEN MARGARET & GRINNELL STREETS; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 P.M. TO 10:00 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Business Guild wishes to conduct a fundraiser for toys for tots on Wednesday, November 10, 2010 on the 900 block of Fleming street between Margaret & Grinnell.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That Key West Business Guild is hereby granted permission to conduct a fundraiser on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and 25% of gross revenue or \$1,000.00, whichever is greater shall be donated to the Key West Police Department Holiday Toy Drive.

SECTION 2. That the Key West Business Guild is hereby granted permission for the closure of Fleming Street between Margaret & Grinnell Streets on the date and during the hours stated above.

SECTION 3. That the Key West Business Guild is hereby granted a Special Event

Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Business Guild is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That the Key West Business Guild will adhere to the recycling plan of the City of Key West.

SECTION 6. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
