

RESOLUTION NO. 18-342

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF PAC COMM, INC. (PAC) IN RESPONSE TO ITB #18-036 IN A TOTAL AMOUNT NOT TO EXCEED \$818,570.00, FOR AQUARIUM SEAWALL REPAIR (HURRICANE IRMA DAMAGE); APPROVING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in September 2017, Hurricane Irma caused extensive damage to the Aquarium Seawall, and other structures and facilities in Key West; and

WHEREAS, two responsive bids were opened on September 26, 2018, in response to ITB #18-036 and City staff recommends award of bid to the lowest responsive bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of PAC Comm, Inc. is hereby awarded in an amount not to exceed \$818,570.00, as specified in the response to ITB #18-036, the terms and conditions of which are incorporated herein.

Section 2: That this project will be funded from account 001-1910-519-6500, General Fund/Disaster Recovery (Project HU1701E01). This project will be submitted upon completion to FEMA for possible Federal and State reimbursement, due to Hurricane Irma damage, and any necessary budget transfers are authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney, that are consistent with ITB #18-036 and the approval granted herein.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
