A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING AN EASEMENT OF APPROXIMATELY 77.70 SQUARE FEET IN ODER TO MAINTAIN EXISTING EAVES, PORCHES AND PARTIAL FENCE AND GATE THAT ENCROACH ON CITY RIGHT OF WAY LOCATED AT 506 ELIZABETH STREET, KEY WEST, FLORIDA (RE#00009080-0000000, AK #1009342); PROVIDING FEES AND CONDITIONS; PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an easement of approximately 77.70 square feet for the real property described in the attached specific purpose survey prepared by Florida Keys Land Surveying, dated March 4, 2014, is granted subject to the execution of the attached easement agreement, incorporating the minimum conditions described in section 2 below.

Section 2: That the following conditions shall apply to the grant of easement: (1) That the easement shall terminate upon the replacement of the structure. (2) The City may unilaterally terminate the easement upon a finding of public

purpose by a vote of the Key West City Commission. (3) The owner shall pay the annual fee of \$300,00, specified in Code Section The owner shall irrevocably appoint the City 2-938(b). (4) its agent to permit the removal Manager as encroachment(s) if the annual fee required by the Code of Ordinances is not paid. (6) The easement shall terminate upon failure of the property owner to maintain liability insurance in a minimum amount of \$200,000.00 per person and incident, or such other \$300,000.00 per amount may legislatively be determined to be the maximum extent sovereign immunity waiver, naming the City as an additional insured for that portion of real property which is the subject of this easement. (7) The existing eaves, porches and partial fence and gate shall be the only total allowed construction within the easement area. (8) The easement area shall not be used in site size calculations such as lot, yard, and bulk calculations for site development. (9) The City reserves the right to construct surface or sub-surface improvements within the easement area.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
