Description of Work:

Change to previous design. Extension of left side of north elevation of house. Elevation increase by 7.5" 2'5". Pool size reduction to 16' x 9'.

Site Facts:

The original building on this site has been demolished (2nd reading approved on June 24, 2025). The building was a contributing structure within the historic district, originally constructed around 1940 as a multi-family residence. However, staff found evidence indicating that the building predates 1940, as a smaller version appears on the 1926 Sanborn Map. The site is now vacant and is located within an X flood zone.

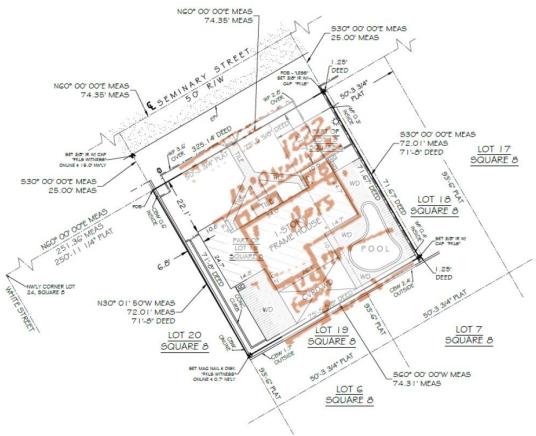

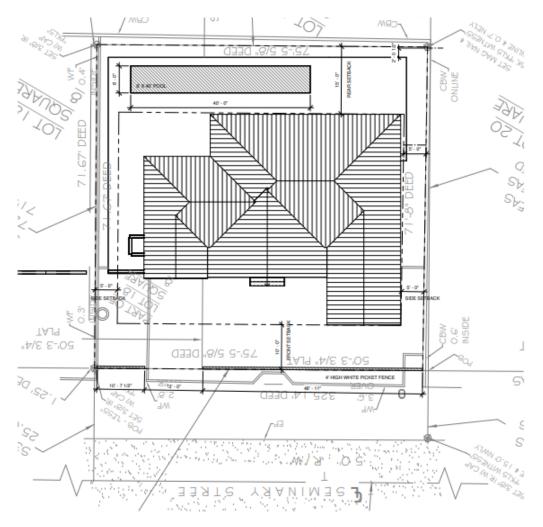

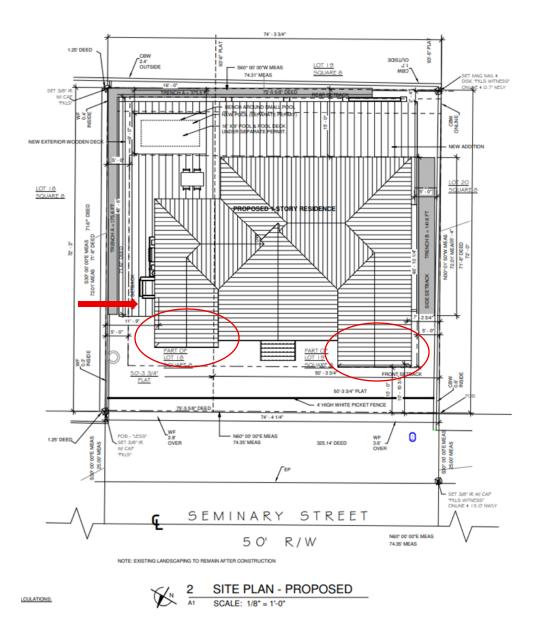

Staff Analysis:

A Certificate of Appropriateness is currently under review for revisions to the previously approved design dated May 27, 2025. The updated plans propose extending the north elevation of the house approximately 25' to $31'\,3\frac{1}{2}"$ on the left side and approximately 45' $9\frac{1}{4}"$ to $46'\,10\frac{1}{4}"$ on the right side, as shown on the submitted drawings. The building will be elevated approximately 7.5" higher than previously approved, resulting in the addition of new front steps. The pool will be reduced in size from $40'\times6'$ to $16'\times9'$. All proposed materials remain consistent with the prior approval, including Hardie siding, aluminum impact-rated windows and doors (with a half-glazed front door), 5V-crimp metal roofing, and pressure-treated wood decking.

Consistency with Cited Guidelines:

Staff finds that the overall design is cohesive and compatible with the surrounding context. If approved, staff recommends that the A/C unit be properly screened with an enclosure, landscaping or fencing, as it will become more visible on the front elevation once the house is elevated. Overall, the proposed Hardie siding, aluminum impact-rated windows and doors, and 5V-crimp metal roofing are appropriate material choices for new construction within the historic district.

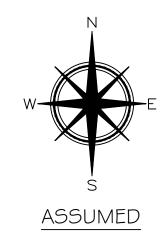

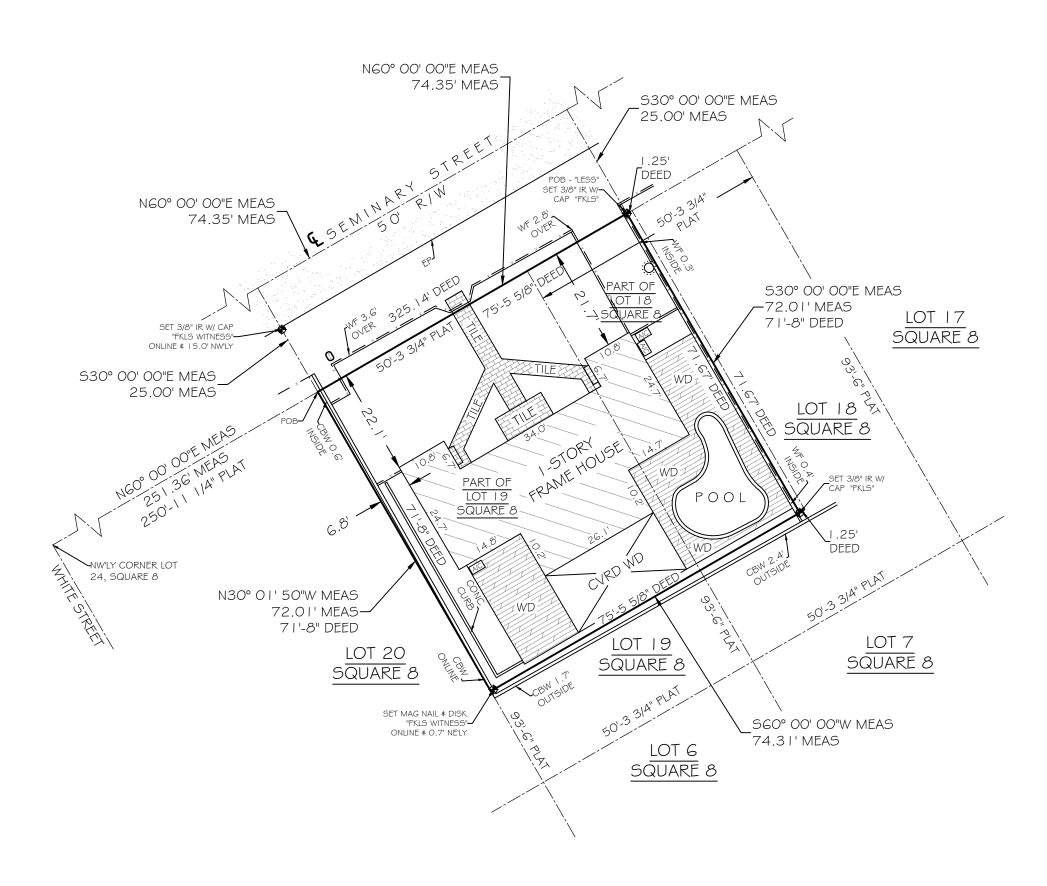
