A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE MARKER RESORT TO HOLD THE "SALUTE TO SERVICE 5K" ON SUNDAY, MAY 25, 2025, FROM 8:00 A.M. TO 10:00 A.M. BEGINNING AT THE MARKER RESORT; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF FOR SAID RACE FROM 8:00 A.M. TO 10:00 A.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Marker Resort wishes to conduct the "Salute to Service 5K" beginning and ending at The Marker Resort during the hours of 8:00 a.m. to 10:00 a.m. on May 25, 2025; and

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using

disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore, commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City."

SECTION 3. That The Marker Resort is hereby granted permission to hold "Salute to Service 5K" starting and ending at The Marker Resort on Sunday, May 25, 2025, from 8:00 a.m. to 10:00 a.m.; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 4. That The Marker Resort is hereby granted permission for the closure of certain streets throughout the city for the "Salute to Service 5K" on the date and during the hours stated above.

SECTION 5. That The Marker Resort will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That The Marker Resort acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 7. That a \$5,000 donation will be made to the VFW Post 3911.

SECTION 8. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
