RESOLUTION OF THE CAROLINE STREET Α CORRIDOR BAHAMA VILLAGE AND COMMUNITY REDEVELOPMENT AGENCY (CRA) APPROVING THE 5-YEAR LEASE RENEWAL BETWEEN THE CRA AND RED HOSPITALITY & LEISURE KEY WEST, LLC dba SEBAGO WATERSPORTS FOR THE LAZY WAY TICKET/CHECK-IN BOOTH IN THE HISTORIC SEAPORT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on April 9, 2025, via Resolution KWBB 25-09, the Key West Bight Management District Board recommended the CRA approve and execute the proposed lease renewal between the CRA and RED Hospitality & Leisure Key West, LLC, dba Sebago Watersports for the Lazy Way ticket/check-in booth; and

WHEREAS, RED Hospitality & Leisure Key West, LLC, operating Sebago Watersports, has been the tenant by assignment at Key West Bight since 2019. The lease for the Lazy Way ticket/check-in booth will expire on May 31, 2025 and the tenant has requested a lease renewal under the following terms; and

WHEREAS, the Lease Renewal consists of a term of 60 months, commencing June 1, 2025 and ending on May 31, 2030 at the rate of \$2,776.67 per month with the base rent to be adjusted annually by any increase in the Consumer Price Index; and the tenant to pay for all utilities; and WHEREAS, the rent reflects a 4.5% increase over the current rental rate and will be adjusted annually for inflation; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: The 5-year Lease Renewal with RED Hospitality & Leisure Key West, LLC, dba Sebago Watersports for the lease of the Lazy Way Lane ticket/check-in booth in the Historic Seaport is hereby approved.

<u>Section 2</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
