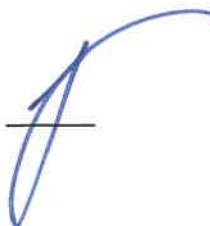

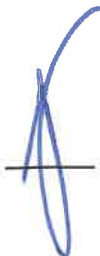
- 5 Responsive to public records requests in a timely manner
