SECTION 3. That the Key West Business Guild is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, the Key West Business Guild is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.
