**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES TO BOURBON STREET PUB FOR AN EVENT TO TAKE PLACE DURING THE HOURS OF 7:00 P.M. TO 12:00 MIDNIGHT AT 724 DUVAL STREET ON THURSDAY, JUNE 10, 2010 AND FRIDAY, JUNE 11, 2010; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance; and

**WHEREAS**, Bourbon Street Pub has applied to the City for a Special Event Permit for an event at Bourbon Street Pub Thursday, June 10, 2010 and Friday, June 11, 2010; and

**WHEREAS**, this event shall take place on the grounds of the Bourbon Street Pub at 724 Duval Street between the hours of 7:00 p.m. and 12:00 midnight; and

**WHEREAS**, amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida:

**SECTION 1.** That the Bourbon Street Pub is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

**SECTION 2.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the

Commission.
