A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A CHANGE ORDER THE PROCUREMENT AUTHORIZED IN RESOLUTION #020588), 23-033 (PR ADJUSTING IN PART QUANTITY AND TYPE OF VEHICLES TO TWENTY-ONE (21)FORD POLICE INTERCEPTOR ECOBOOST SUV VEHICLES, FROM TWENTY-TWO (22)FORD SUV VEHICLES, TO BE PROCURED INTERCEPTOR HYBRID FROM BARTOW FORD, THROUGH PIGGYBACKING ON CHARLOTTE COUNTY PURCHASING CONTRACT 2021000541, PURSUANT TO SECTION 2-797(3)(a)(b) (c) AND 2-797(4)(b) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST POLICE DEPARTMENT; NECESSARY AUTHORIZING ANY BUDGET OR ADJUSTMENTS; AUTHORIZING THE CITY OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 23-033 the City Commission authorized the procurement of twenty-two Police Interceptor Hybrid SUVs, along with other vehicles, and related equipment under the Charlotte County Government Bid No. 2021000541, pursuant to section 2-797(3)(a)(b)(c) and 2-797(4)b (best interests) of the Code of Ordinances; and

WHEREAS, supply issues through the manufacturer impacted the availability of the Hybrid SUV vehicles, with an expectation that such vehicles may not be available until model year 2024, at undetermined additional cost. The vendor, along with KWPD staff recommends as an alternative, the procurement of twenty-one 2023 Ford Police Interceptor EcoBoost vehicles in place of the originally quoted vehicles; and

WHEREAS, the City Commission finds this change order to be in the best interests of the City, pursuant to Section 2-797(4)(b) of the code of ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a change order to the procurement authorized in Resolution 23-033 is hereby approved, to authorize the purchase of twenty-one (21) Ford Police Interceptor EcoBoost SUVs (Unit cost \$60,769.23) in lieu of the twenty-two (22) 2023 Ford Police Interceptor SUV Vehicles (Unit cost \$59,501.10 approved, but not currently available) from Bartow Ford, pursuant to section 2-797(3)(a)(b)(c), and 2-797(4)(b) of the Code of Ordinances, under the Charlotte County Government Purchasing Contract 2021000541 for use by the Key West Police Department.

Section 2: Remaining provisions authorized in Resolution 23-033, including procurement of other vehicles, are not altered by this change order.

Section 3: That funds for this purchase are budgeted in FY 23 under account number 101-2101-521-6400. Any necessary budget amendments or adjustments are hereby authorized. (Cost of the procurement will be reduced from \$1,309,024.20 to \$1,276,253.83, due to the smaller quantity of vehicles being procured.)
